

- A.** The Regular Meeting of the Santee City Council School Committee and Santee Elementary School District Conference Committee was called to order by Santee Vice Mayor Rob McNelis at 5:10 p.m. Present were Vice Mayor Rob McNelis, Council Member John Minto, Acting City Manager Pedro Orso-Delgado; School Board President Ken Fox, School Board Vice President Dustin Burns, and District Superintendent Cathy Pierce.

B. APPROVAL OF MEETING MINUTES OF MAY 15, 2013

The Meeting Minutes of May 15, 2013 were approved as submitted with all voting aye.

C. SCHOOL DISTRICT ITEMS:

1. Update and Discussion on the Disposition of the Santee School Site

The School District discussed rezoning of the Santee School site, expressing their desire to have the property rezoned so that they can move ahead with putting it up for sale. The City expressed that staff will be preparing an agenda item to discuss rezoning at the second meeting in July at the earliest, and would involve both the rezoning of this site as well as the Renzulli site.

2. Update and Discussion on the Disposition of the Renzulli Site

The District communicated that they put the Renzulli site up for bid and Mr. Grant was the successful bidder. The District explained that after working with City staff the Renzulli site was placed on the market with a condition that the front 3.77 acres remained open space and the rest of the site would be developed as R7. Mr. Grant expressed a desire to modify this and have the entire site developed and pay Park in Lieu fees. The School District expressed concern to the City about whether the site would be allowed to be fully developed.
