- 1 inch air space between top of roof deck to the bottom of roofing product
- Ducts are insulated to R-6 and sealed (must be verified by HERS report)
- Building has R-38 insulation
- Building has a radiant barrier in the attic
- Building has no ducts in the attic
- R-4 min. insulation above roof deck
- Roofing is covered by integrated photovoltaic panels
- Roof construction having thermal mass over the roof membrane of at least 25lbs per square foot
