6C. SANTEE LAKESIDE EMERGENCY MEDICAL SERVICES AUTHORITY INTERIM BUDGET (ACTION)

The Interim Budget is for initial review, discussion, and approval. The proposal of the Interim budget is to establish an approved budget in which to operate the SLEMSA through June 30, 2023. After this date SLEMSA will operate under a traditional Operating Budget.

The SLEMSA Interim Budget totals \$1,282,360. A portion of this budget is the PP GEMT IGT payment of \$839,300. The remain operating expenditures are \$443,060. Estimated revenue through January 2023 to June 2023 is \$6,338,300 with the PP GEMT IGT portion to be \$1,089,300. The JPA will receive a distribution on February 1, 2023 from the County representing ninety percent (90%) of the CSA 69's current fund balance. The JPA will receive additional distributions of remaining funds in June 2023, February 2024 and a final distribution in June 2024.

It was requested of staff to send the next budget for approval to the Commissioners at least 2 week ahead of the meeting which the items is being taken for approval.

Agenda Item Title: CONFLICT OF INTEREST CODE (COI) FOR THE JPA

Recommended Action: It is recommended that the Commission review and adopt Resolution # 23-001 approving the Conflict of Interest Code.

Discussion: One of the purposes of the Political Reform Act of 1974, as codified in Government Code Section 87100 et seq. (the "Act"), is to require that local government agencies serve the needs and respond to the wishes of all citizens equally, without regard to their wealth. Another purpose of the Act is to assure that public officials and employees perform their duties in an impartial manner free from bias caused by their own financial interests or the financial interests of those who have supported them.

As a local government agency, the Santee-Lakeside Emergency Medical Services Authority ("SLEMSA") is required to adopt and promulgate a Conflict of Interest Code (the "Code") in accordance with the Political Reform Act (Government Code Section 8100, et seq.). Government Code Section 87302 requires SLEMSA to adopt and promulgate a Conflict of Interest Code (the "Code") to implement the purposes of the Act with respect to certain designated employees and consultants of SLEMSA. In addition, SLEMSA's Code incorporates the requirement that the JPA abide by the provisions of the Political Reform Act as it exists or may be amended from time to time by the Fair Political Practices Commission ("FPPC").

The Code must contain an enumeration of the positions within SLEMSA which involve the making or the participating in making of decisions which may be foreseeable and have a material effect on any financial interest. The Code must also contain a requirement that certain designated employees and consultants file at a specified time statements of economic interests disclosing reportable investments, interests in real property and income.

In addition, the Code must contain specific provisions setting forth any circumstances under which specified designated employees and consultants must disqualify themselves from making, participating in the making or using their official position to influence the making of any decision when the designated employee or consultant has a financial interest wherein it is reasonably foreseeable may be affected materially by the decision. The positions designated in the Code as required to file statements of economic interests are in addition to those positions listed in Government Code section 87200, which are statutorily required to file statements of economic interest under Government Code sections 87201, *et seq*.

As a new agency, SLEMSA is initially adopting and approving the Code as required by the Act. Following SLEMSA's initial approval and adoption of the Code, the FPPC requires that all local government agencies review their codes biennially.

Upon approval, SLEMSA's Code will be submitted to SLEMSA's Code Reviewing Body, the San Diego County Board of Supervisors, for review and approval, pursuant to Government Code section 87303. Upon review and approval of the Code by the San Diego County Board of Supervisors, the Code shall become effective.

RESOLUTION OF THE COMMISSON FOR THE SANTEE-LAKESIDE EMERGENCY MEDICAL SERVICES AUTHORITY APPROVING ITS CONFLICT OF INTEREST CODE

WHEREAS, one of the purposes of the Political Reform Act of 1974, as codified in Government Code Section 87100 et seq. (the "Act"), is to require that local governments serve the needs and respond to the wishes of all citizens equally, without regard to their wealth; and

WHEREAS, another purpose of the Act is to assure that public officials and employees perform their duties in an impartial manner free from bias caused by their own financial interests or the financial interests of those who have supported them; and

WHEREAS, as a local government agency, the Santee-Lakeside Emergency Medical Services Authority ("SLEMSA") is required to adopt and promulgate a Conflict of Interest Code (the "Code") in accordance with the Political Reform Act (Government Code Section 8100, et seq.); and

WHEREAS, Government Code Section 87302 requires SLEMSA to adopt and promulgate a Conflict of Interest Code (the "Code"), attached hereto as Exhibit "A," to implement the purposes of the Act with respect to certain designated employees and consultants of SLEMSA; and

WHEREAS, in addition, SLEMSA's Code incorporates the requirement that the District abide by the provisions of the Political Reform Act as it exists or may be amended from time to time by the Fair Political Practices Commission ("FPPC"); and

WHEREAS, the Code must contain an enumeration of the positions within SLEMSA which involve the making or the participating in making of decisions which may be foreseeable and have a material effect on any financial interest; and

WHEREAS, the Code must contain a requirement that certain designated employees and consultants file at a specified time statements of economic interests disclosing reportable investments, interests in real property and income; and

WHEREAS, the Code must contain specific provisions setting forth any circumstances under which specified designated employees and consultants must disqualify themselves from making, participating in the making or using their official position to influence the making of any decision when the designated employee or consultant has a financial interest wherein it is reasonably foreseeable may be affected materially by the decision; and

WHEREAS, the positions designated in the Code as required to file statements of economic interests are in addition to those positions listed in Government Code section 87200, which are statutorily required to file statements of economic interest under Government Code sections 87201, et seq.; and

WHEREAS, as a new agency, SLEMSA is adopting and approving the Code as required

by the Act; and

WHEREAS, following SLEMSA's initial approval and adoption of the Code, the FPPC requires that all local government agencies review their codes biennially; and

WHEREAS, SLEMSA's Code will be submitted to SLEMSA's Code Reviewing Body, the San Diego County Board of Supervisors, for review and approval pursuant to Government Code section 87303, at which point the Code will become effective.

NOW, THEREFORE, BE IT RESOLVED, the Santee-Lakeside Emergency Medical Services Authority hereby resolves, determines, and orders as follows:

SECTION 1: That the Conflict of Interest Code of the Santee-Lakeside Emergency Medical Services Authority, a Public Agency, attached hereto as Exhibit "A", is hereby approved and adopted.

SECTION 2: Upon approval, the Conflict of Interest Code, attached hereto as Exhibit "A," will thereafter be submitted to Santee-Lakeside Emergency Medical Services Authority's Code reviewing body, the San Diego County Board of Supervisors, for review and approval pursuant to Government Code section 87303.

SECTION 3: Upon review and approval by the Santee-Lakeside Emergency Medical Services Authority's Code reviewing body, the San Diego County Board of Supervisors, the Code shall become effective.

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendix "A" and Appendix "B", designating positions and establishing disclosure categories, shall constitute the conflict of interest code of the Santee-Lakeside Emergency Medical Services Authority ("SLEMSA").

Individuals holding designated positions shall file their statements of economic interests with SLEMSA, which will make the statements available for public inspection and reproduction (Gov. Code Sec. 81008). All statements will be retained by SLEMSA.

Agenda Item Title: SLEMSA PRELIMINARY OPERATING BUDGET

Recommended Action: Adopt Resolution 23-002 approving the SLEMSA Preliminary Operating Budget

Discussion:

The Preliminary Operating Budget is presented to the SLEMSA Commission and public for review, discussion, and adoption. The purpose of the Preliminary Operating Budget is to establish an approved budget in which to operate the SLEMSA until the Final Operating Budget is developed.

With the dissolution of CSA 69, the SLEMSA is now managing the ambulance billing, collecting and distributing billing revenue, reconciling Fire Benefit Fee and Property Tax revenues, and allocating all revenues to the City of Santee and the Lakeside Fire Protection District on an equal basis. The Preliminary Operating Budget accounts for the revenues received and the expenditures necessary to support the JPA and its activities.

The JPA's expenditures are primarily tied to the costs associated with collecting, distributing, and reconciling the Authority's revenues. The JPA is responsible for the following expenditures; billing contractor, Administrative Service Provider (ASP) fee, SLEMSA attorney fees, bank fees, audit fees, special tax consultant, and other necessary items. The Preliminary Operating Budget includes a payment amount for participation in the Public Provider Ground Emergency Transport Intergovernmental Transfer (PP GEMT IGT) program. This program has been set up to assist ambulance carriers in collecting an add-on increase to the fee-for-services fee schedule. The program requires an upfront payment.

Fiscal Impact:

The SLEMSA Preliminary Operating Budget totals \$1,928,890. A significant portion of this budget is the PP GEMT IGT payment of \$1,396,500. The remaining operating expenditures are \$532,390. Estimated revenue for Fiscal Year 2023-24 is \$11,757,200 with the PP GEMT IGT portion expected to be \$1,896,500. The JPA continues to receive distributions from the County of San Diego for collected CSA 69 revenues, such as older ambulance billings (prior to January 1, 2023), GEMT, property tax and special assessment taxes. The JPA will receive distributions from the County of San Diego of remaining funds in June 2023, February 2024 and a final distribution in June 2024

BE IT FURTHER RESOLVED by the Commission for the Santee-Lakeside Emergency Medical Services Authority that the means of financing the expenditure requirement will be by monies derived from all revenue sources, available fund balance, and designated reserve fund balances; and

BE IT FURTHER RESOLVED that the Final Budget will be adopted prior to October 1, 2023, in accordance with Section 13895 of the Health & Safety Code.

Agenda Item Title: THE FIRST AMENDMENT TO THE SANTEE – LAKESIDE EMERGENCY MEDICAL SERVICES AUTHORITY JOINT EXERCISE OF POWER AGREEMENT

Recommended Action: It is recommended that the Commission review and approve the first amendment to the JPA agreement.

Discussion:

The purpose of the original Agreement is to (1) create the Santee-Lakeside Emergency Medical Services Joint Powers Authority; (2) to provide for the administration of the Authority; and (3) to jointly through the Authority exercise the common powers of the Parties by administering, funding, managing and overseeing coordination of ALS ambulance transport services by the member agencies.

The Agreement may be amended by a majority vote of the Commission only after approval of two-thirds vote of the member agencies. The Commission shall initiate any proposed amendment by requesting a formal recommendation from the Board of Chiefs, if applicable. The Commission shall then forward the proposed amendment with its recommendation to the governing body of each member agency to the Agreement. The proposal shall be accompanied by a copy of the proposed amendment to the Agreement, which shall be adopted, properly executed, and returned to the Commission if the member agencies concur with the amendment.

WHEREAS, on or about August 23, 2022, the Parties entered into the Santee-Lakeside Emergency Medical Services Authority Joint Exercise of Powers Agreement ("Agreement") pursuant to Articles 1 through 4, Chapter 5, Division 7, Title 1 of the Government Code of the State of California (commencing with Section 6500) relating to the joint exercise of powers common to public agencies by the Parties to permit the joint exercise of certain powers both have in common; and

WHEREAS, the Parties are authorized to jointly exercise their powers pursuant to the provisions of Article 2, Chapter 4; Part 2, Division 2, Title 5, Sections 55631 through 55634, and Articles 1 through 4, Chapter 5, Division 7, Title 1 (commencing with Section 6500), of the Government Code of the State of California; and

WHEREAS, the purpose of the Agreement is to (1) create the Santee-Lakeside Emergency Medical Services Joint Powers Authority; (2) to provide for the administration of the Authority; and (3) to jointly through the Authority exercise the common powers of the Parties by administering, funding, managing and overseeing coordination of ALS ambulance transport services by said Member Agencies. Such purpose is accomplished and common powers exercised in the manner set forth in the Agreement; and

WHEREAS, the Agreement stated above may be amended by a majority vote of the Commission only after approval of two-thirds vote of the Member Agencies. The Commission shall initiate any proposed amendment by requesting a formal recommendation from the Board of Chiefs, if applicable. The Commission shall then forward the proposed amendment with its recommendation to the governing body of each Party to the Agreement. The proposal shall be accompanied by a copy of the proposed amendment to the Agreement, which shall be adopted, properly executed, and returned to the Commission if the Party concurs with the amendment. The Secretary shall notify each Party of the resultant action; and

WHEREAS, the Member Agencies wish for this First Amended Agreement to amend the terms of the Agreement stated above regarding the subject matters contained herein, and for the new terms to be effective on the last signature date on the First Amended Agreement; and

WHEREAS, the Member Agencies desire for all terms of the previous Agreement referenced above to remain effective to the extent they are not amended by this First Amended Agreement.

NOW, THEREFORE, BE IT RESOLVED, the Commission of the Santee-Lakeside Emergency Medical Services Authority hereby resolves, determines, and orders as follows:

SECTION 1: The above recitals are true and correct and are deemed to be findings by the Commission.

SECTION 2: Section 17 of the Agreement shall be amended as set forth in the First Amended Agreement attached to this Resolution as Exhibit "A."

FIRST AMENDMENT TO SANTEE-LAKESIDE EMERGENCY MEDICAL SERVICES AUTHORITY JOINT EXERCISE of POWERS AGREEMENT

THIS FIRST AMENDMENT TO JOINT EXERCISE OF POWERS AGREEMENT ("("First Amended Agreement")Amendment") is made and entered into this ______ day of <u>December 2022</u> 2023, by and between the City of Santee ("("Santee"),"), a California charter city and municipal corporation, and the Lakeside Fire Protection District ("("LFPD") (collectively, "Parties"),"), organized and existing under the Fire Protection District Law of 1987, Health and Safety Code section 13800 *et seq.* (collectively, "Parties").

RECITALS

WHEREAS, the Parties are authorized to jointly exercise their powers pursuant to the provisions of Article 2, Chapter 4; Part 2, Division 2, Title 5, Sections 55631 through 55634, and Articles 1 through 4, Chapter 5, Division 7, Title 1 (commencing with Section 6500), of the Government Code of the State of California; and

WHEREAS, on or about August 23, 2022, the Parties entered into the Santee-Lakeside Emergency Medical Services Authority Joint Exercise of Powers Agreement ("("Agreement")") pursuant to Articles 1 through 4, Chapter 5, Division 7, Title 1 of the Government Code of the State of California (commencing with Section 6500) relating to the joint exercise of powers common to public agencies by the Parties to permit the joint exercise of certain powers both have in common; and

WHEREAS, the purpose of the Agreement is to (1) create the Santee-Lakeside Emergency Medical Services Joint Powers Authority; (2) to provide for the administration of the Authority; and (3) to jointly through the Authority exercise the common powers of the Parties by administering, funding, managing and overseeing coordination of <u>ALSadvanced life support</u> ambulance transport services by said Member Agencies. Such purpose is accomplished and common powers exercised in the manner set forth in the Agreement; and

WHEREAS, the Agreement stated above may be amended by a majority vote of the Commission only after approval of two-thirds vote of the Member Agencies. The Commission shall initiate any proposed amendment by requesting a formal recommendation from the Board of Chiefs, if applicable. The Commission shall then forward the proposed amendment with its recommendation to the governing body of each Party to the Agreement. The proposal shall be accompanied by a copy of the proposed amendment to the Agreement, which shall be adopted, properly executed, and returned to the Commission if the Party concurs with the amendment. The Secretary shall notify each Party of the resultant action; and

WHEREAS, the Parties wish for this First <u>Amended AgreementAmendment</u> to amend the terms of the Agreement<u>stated above</u> regarding the subject matters contained herein, and for the new terms to be effective on the last signature date set forth below ("("Effective Date");"); and

WHEREAS, the Parties desire for all terms of the previous Agreement referenced above to remain effective to the extent they are not amended by this First Amended

AgreementAmendment.

NOW, THEREFORE, the Parties, for and in consideration of the mutual benefits, promises, and agreements set forth herein, agree as follows:

AGREEMENT

Section 1. The foregoing recitals are true and correct.

Section 2. Section 17 of the Agreement is hereby revised to read as follows:

SECTION 17. Hold Harmless.

Each Member Agency agrees to defend, indemnify, and hold harmless the other individual Member Agencyies (including itstheir officers, elected or appointed officials, employees, agents, and volunteers) and the Authority (including its officers, elected or appointed officials, employees, agents, and volunteers) from and against any and all claims, damages, losses, expenses, fines, penalties, judgments, demands and defense costs (including, without limitation, actual, direct, out-of-pocket costs and expenses and amounts paid in compromise or settlement and reasonable outside legal fees arising from litigation of every nature or liability of any kind or nature including civil, criminal, administrative or investigative) arising out of or in connection with thethat individual Member Agency"s (including its officers, elected or appointed officials, employees, agents and volunteers) negligent or reckless performance of duties or activities arising under this Agreement or as a result of the management by and operations of the Member Agency providing Emergency Medical Services pursuant to the Agreement. The provisions of this Section 17 shall survive the termination or expiration of this Agreement.

The Authority shall defend, indemnify, and hold harmless each Member Agency (including the Member Agency's officers, elected or appointed officials, employees, agents, and volunteers) from any and all claims, damages, losses, expenses, fines, penalties, judgments, demands and defense costs (including, without limitation, actual, direct, out-of-pocket costs and expenses and amounts paid in compromise or settlement and reasonable outside legal fees arising from litigation of every nature or liability of any kind or nature including civil, criminal, administrative or investigative) arising out of or in connection with the negligent acts, errors, or omissions of the Commission or Board of Chiefs, while acting within the scope of their authority under this Agreement, including but not limited to, claims arising under the Ralph M. Brown Act (Gov. Code § 54950 et seq.), the Political Reform Act (Gov. Code § 81000 et seq.), or Government Code section 1090. This duty to defend, indemnify, and hold harmless only applies to the limited governance functions performed by the Commission or Board of Chiefs. It expressly does not apply to any operational issues that are performed by the Member Agencies, who are solely responsible for operational activities.

The provisions of this Section 17 shall survive the termination or expiration of this Agreement.

Section 3. Subsection (G)(2)(g) of Section 9 of the Agreement is deleted in its entirety.
