Dear Ms. George:

This report summarizes the cultural resources records search results for the St. John the Baptizer Ukrainian Catholic Church Project (project).

RECON requested a records search of the project area with a mile-radius buffer from the California Historical Resources Information System at the South Coastal Information Center (SCIC). This included previously recorded cultural resources, previous archaeological surveys and excavations, and historic maps and historic addresses (Attachment 1). The National Register of Historic Places, the California Register of Historical Resources for San Diego County, and the County of San Diego's Local Register of Historical Resources were also reviewed.

The SCIC records search indicates that there have been 101 investigations within the mile search area, two of which were within the project area (Attachment 2). Six historic period sites, nine prehistoric sites, one multi-component site, and one with no information have been recorded within a mile search area of the project area (Table 1; Confidential Attachment A). The historic sites include a single-family residence, a religious building, an industrial building, a commercial building, Santee Lakes, and Fanita Ranch. The prehistoric sites include bedrock milling features, lithic scatters, ceramic scatters, shell scatter, and ground stone scatters. Additionally, 18 historic addresses have been recorded within the one-mile search area. None are recorded within the project area.
