- 3. UPDATES ON NEIGHBORHOOD WATCH AND CRIME PREVENTION EVENTS:**

Marlene Best stated the City Council did approve a regional participation level homeless MOU a partnership with other east county cities to develop a regional approach to deal with homeless issues. She stated other river bed mitigation efforts.

Danette McLagan complemented the presentation and stated it is Pride month.

Mayor Minto mentioned how the economy affects crime and only using your own prescriptions and thanked committee for participation.
