SUMMARY

This item asks the City Council to waive the reading in full of all ordinances on the agenda (if any) and approve their reading by title only. The purpose of this item is to help streamline the City Council meeting process, to avoid unnecessary delay and to allow more time for substantive discussion of items on the agenda.

State law requires that all ordinances be read in full either at the time of introduction or at the time of passage, unless a motion waiving further reading is adopted by a majority of the City Council. (Gov. Code, § 36934). This means that each word in each ordinance would have to be read aloud unless such reading is waived. Such reading could substantially delay the meeting and limit the time available for discussion of substantive items. Adoption of this waiver streamlines the procedure for adopting the ordinances on tonight's agenda (if any), because it allows the City Council to approve ordinances by reading aloud only the title of the ordinance instead of reading aloud every word of the ordinance.

The procedures for adopting resolutions are not as strict as the procedures for adopting ordinances. For example, resolutions do not require two readings for passage, need not be read in full or even by title, are effective immediately unless otherwise specified, do not need to be in any particular format unless expressly required, and, with the exception of fixing tax rates or revenue amounts, do not require publication. However, like ordinances, all resolutions require a recorded majority vote of the total membership of the City Council. (Gov. Code § 36936).

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SANTEE, ADDING CHAPTER 11.50 TO TITLE 11 OF THE MUNICIPAL CODE IMPLEMENTING THE REQUIREMENTS OF AB 1236 TO STREAMLINE PROCESSING OF PERMIT APPLICATIONS FOR ELECTRIC VEHICLE CHARGING STATIONS, AND DETERMINING ORDINANCE IS NOT SUBJECT TO ENVIRONMENTAL REVIEW UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

WHEREAS, the State of California and the City of Santee have consistently promoted and encouraged the use of fuel-efficient electric vehicles; and

WHEREAS, the State of California adopted Assembly Bill 1236, which requires local agencies to adopt an ordinance that creates an expedited and streamlined permitting process for electric vehicle charging systems; and

WHEREAS, creation of an expedited, streamlined permitting process for electric vehicle charging stations would facilitate convenient charging of electric vehicles and help reduce reliance on environmentally damaging fossil fuels; and

WHEREAS, pursuant to the California Environmental Quality Act (CEQA) and the State of California Guidelines for Implementation of CEQA (commencing with Section 15000 of Title 14 of the California Code of Regulations), the City is the "lead agency" for the preparation and consideration of environmental documents for this ordinance; and

WHEREAS, the City Council finds and determines that this ordinance is not subject to CEQA pursuant to Sections 15060 (c)(2) and 15060(c)(3) of the Title 14 of the California Code of Regulations because it will not result in a direct or reasonably foreseeable indirect physical change in the environment and is not a project; and

WHEREAS, on April 9, 2020, the Department of Development Services published a Notice of Public Hearing on the proposed addition of Chapter 11.50, Title 11, of the Santee Municipal Code informing the public of consideration of the ordinance first reading at the City Council meeting of April 22, 2020; and

WHEREAS, on April 22 2020, the City Council held a duly advertised public hearing on the proposed amendment to the Santee Municipal Code; and

WHEREAS, the City Council considered the staff report, all recommendations by staff and public testimony.

NOW, THEREFORE, the City Council of the City of Santee, California, does ordain as follows:

<u>Section 1.</u> The Santee City Council hereby finds and determines that the above recitals are true and correct and incorporated herein.

ORDINANCE NO.

<u>Section 2.</u> This ordinance is not subject to CEQA because the adoption of this ordinance is not a "project" pursuant to Section 15060 (c)(2) and 15060 (c)(3) of Title 14 of the California Code of Regulations. Specifically, this ordinance only establishes a streamline process for electric vehicle charger permits and is merely authorizing administrative activities which will not result in a direct or reasonably foreseeable indirect physical change in the environment.

<u>Section 3.</u> Chapter 11.50 is added to the Santee Municipal Code to read in full as follows:

ELECTRIC VEHICLE CHARGING SYSTEMS EXPEDITED, STREAMLINED PERMITTING PROCESS

11.50.010 Definitions

- A. "Electric vehicle charging station" or "charging station" means any level of electric vehicle supply equipment station that is designed and built in compliance with Article 625 of the California Electrical Code, as it reads on the effective date of this Chapter, and delivers electricity from a source outside an electric vehicle into a plug-in vehicle.
- B. "Specific adverse impact" means a significant, quantifiable, direct, and unavoidable impact, based on objective, identified, and written public health or safety standards, policies, or conditions as they existed on the date the application was deemed complete.
- C. "Electronic submittal" means the utilization of one or more of the following:
 - 1. Electronic mail
 - 2. The Internet
 - Facsimile

11.50.020 Purpose

The purpose of this Chapter is to promote and encourage the use of electric vehicles by creating an expedited, streamlined permitting process for electric vehicle charging stations while promoting public health and safety and preventing specific adverse impacts in the installation and use of such charging stations.

11.50.030 Applicability

This ordinance applies to the permitting of all electric vehicle charging systems in the City of Santee. Electric vehicle charging systems legally established or permitted prior to the effective date of this ordinance are not subject to the requirements of this ordinance unless physical modifications or alterations are undertaken that materially change the size, type or components of an electric vehicle charging system in such a way as to require new permitting. Routine operation and maintenance or like-kind replacements shall not require a permit.

11.50.040 Electric Vehicle Charging System Requirements

- A. All electric vehicle charging systems shall meet the requirements of the California Electrical Code, the Society of Automotive Engineers, the National Electrical Manufacturers Association, and accredited testing laboratories such as Underwriters Laboratories, and rules of the Public Utilities Commission regarding safety and reliability.
- B. Installation of electric vehicle charging stations shall be incorporated into the load calculations of all new or existing electrical services and shall meet the requirements of the California Electrical code. Electric vehicle charging equipment shall be considered a continuous load.
- C. Anchorage of either floor-mounted or wall-mounted electric vehicle charging stations shall meet the requirements of the California Building or Residential Code as applicable per occupancy, and the provisions of the manufacturer's installation instructions. Mounting of charging stations shall not adversely affect building elements.

11.50.050 Duties of the Building Division and the Building Official

- A. All documents required for submission of an electric vehicle charging system application shall be made available on the publicly accessible City of Santee website.
- B. The City of Santee shall adopt a checklist, shown on attached **Exhibit A**, of all requirements with which electric vehicle charging systems shall comply to be eligible for expedited review.
- C. The electric vehicle charging system permit process and checklist shall substantially conform to recommendations contained in the most current version of the "Plug-In Electric Vehicle Infrastructure Permitting Checklist" contained in the "Zero-Emission Vehicles in California: Community Readiness Guidebook" adopted by the Governor's Office of Planning and Research.
- D. The Building Official shall allow the electronic submittal of the electric vehicle charging station application.

11.50.060 Permit Review Requirements

A. Review of the permit application shall be limited to the Building Official's review of whether the application meets local, state and federal health and safety requirements. The application shall be administratively reviewed by the Building Official as a nondiscretionary permit.

ORDINANCE NO.

- B. The City shall not condition approval of an application on the approval of an association, as that term is defined by Civil Code Section 4080.
- C. An application for an electric vehicle charging station shall be deemed complete and the permit available for issuance, when the Building Official determines that the application satisfies all the requirements found in the checklist.
- D. If an application is deemed incomplete, a written plan check correction notice will be available to the applicant within 10 working days, detailing all deficiencies in the application and any additional information or documentation required to be eligible for expedited permit issuance shall be given to the applicant for resubmission.
- E. The Building Official, in consultation with the Director of the Department of Development Services, may require an applicant to apply for a use permit if the Building Official finds, based on substantial evidence, that the electric vehicle charging station could have a specific, adverse impact upon the public health and safety. The Building Official's decision to require a use permit may be appealed by the applicant pursuant to Chapter 13.04.070 of this Code.
- F. If a use permit is required, the application for the use permit may be denied if the Planning Commission makes written findings based upon substantial evidence in the record that the proposed installation would have a specific, adverse impact upon the public health or safety and there is no feasible method to satisfactorily mitigate or avoid the specific, adverse impact. Such findings shall include the basis for the rejection of potential feasible alternatives for preventing the specific, adverse impact. Such decisions may be appealed to the pursuant to Santee Municipal Code Sections 13.04.040 and 13.04.070.

<u>Section 4.</u> Severability. If any section, sentence, clause, phrase, or portion of this ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases thereof be declared invalid or unconstitutional.

<u>Section 5.</u> This Ordinance shall become effective thirty (30) days after its passage. Upon adoption of the Ordinance, the added Chapter 11.50 shall be incorporated into the Municipal Code, Title 11 of the City of Santee.

<u>Section 6.</u> The City Clerk is hereby directed to certify the adoption of this Ordinance, to file a Notice of Exemption, and cause the same to be published as required by law.

<u>SUMMARY</u>

Santee Senior Retirement Communities, LLC has requested that the City vacate a portion of right-of-way in Graves Avenue, adjacent to the Lantern Crest facility which is not needed for public improvements. Refer to the Vacation Exhibit for the excess right-of-way proposed for vacation, highlighted in green.

The dedication of right-of-way required for Graves Avenue was conveyed to the City of Santee by Parcel Map No. 2009-01, File No. 2011-0055825, and recorded January 28, 2011. During the final design of the frontage improvements it was determined that the relocation of the bus stop to the south would provide for better traffic movements. As a result, the required dedication of right-of-way needed was reduced. If the vacation is approved, Santee Senior Retirement Communities, LLC intends to merge the vacated portion of property with the adjoining property as part of the development, P 2007-12. This request is supported by staff as it conforms the right of way consistent with standards and places all maintenance responsibilities of the requested vacated area onto the applicant in perpetuity.

Division 9, Part 3, Chapter 3, Section 8320 of the Streets and Highways Code of the State of California provides the City Council may vacate a public street by holding a public hearing and adopting a resolution of vacation. Staff recommends vacating the excess right-of-way as indicated on Exhibit "B".

ENVIRONMENTAL REVIEW

On August 27, 2008, the City Council approved and adopted Mitigated Negative Declaration (State Clearinghouse Number (2008071057)) by Resolution No. 069-2008, which fully disclosed, evaluated and mitigated the environmental impacts of the project (P 2007-12). No further environmental review is required for the City to adopt this Resolution.





SUMMARY

On June 13, 2018 the City Council approved the *TransNet* Local Street Improvement Program (LSI) for fiscal years 2018/19 through 2022/23 which was subsequently amended on May 22, 2019. Because revenue forecasts have changed, the City is required to amend the LSI program to reflect the changed estimates. Staff proposes amending the current Regional Transportation Improvement Program funding to include updated revenue forecasts for *TransNet* LSI through fiscal year 2024/25, as well as to align the funding for the Regional Transportation Congestion Improvement Program (RTCIP), and the SB1 gas tax that created the Road Maintenance and Rehabilitation Account (RMRA) to the adopted Capital Improvement Program (CIP). Updated and reduced RMRA revenue estimates are expected to be received from the State later this month which will require a future modification to the CIP. The resolution requests City Council amend five projects in the program, including the Santee Rehabilitation and Major Repair Work (SNT04), Santee Slurry Seal Roadway Maintenance (SNT22), Transportation Improvement Master Plan Implementation (SNT23), SR67/Woodside Avenue Interchange Improvements (SNT26), and the Regional Arterial Management System (SNT20) projects.

Under the *TransNet* Extension Ordinance each jurisdiction must hold a public hearing when amending projects using *TransNet* LSI funding that have regional significance consistent with the long-range regional transportation plan. Exhibit A -Table 1, of the resolution reflects the funding changes completed through the next five fiscal years. Street recommendations within Santee Rehabilitation and Major Repair Work (SNT04) and Santee Slurry Seal Roadway Maintenance (SNT22) projects remain consistent with the Pavement Management Analysis report for the next five fiscal years with this amendment.

ENVIRONMENTAL REVIEW

Compliance with the Environmental Quality Act (CEQA) would be required prior to construction authorization.

FINANCIAL STATEMENT

Funding within this amendment will be provided through the *TransNet* LSI, RTCIP and RMRA revenues. Estimated available *TransNet* LSI funding for the recommended projects over next five (5) years is as follows:

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTEE, CALIFORNIA, AMENDING THE TRANSNET LOCAL STREET IMPROVEMENT PROGRAM OF PROJECTS FOR FISCAL YEARS 2020/21 THROUGH 2024/25

WHEREAS, on November 4, 2004, the voters of San Diego County approved the San Diego Transportation Improvement Program Ordinance and Expenditure Plan (*TransNet* Extension Ordinance); and

WHEREAS, the *TransNet* Extension Ordinance provides that SANDAG, acting as the Regional Transportation Commission, shall approve on a biennial basis a multi-year program of projects submitted by local jurisdictions identifying those transportation projects eligible to use transportation sales tax (*TransNet*) funds; and

WHEREAS, the City of Santee was provided with an estimate of annual *TransNet* local street improvement revenues for fiscal years 2020/21 through 2024/25; and

WHEREAS, the City of Santee approved its fiscal years 2018/19 through 2022/23 *TransNet* Local Street Improvement Program of Projects (POP) on June 13, 2018 which was subsequently amended on May 22, 2019 and the City of Santee desires to again amend its Program of Projects; and

WHEREAS, the City of Santee has held a noticed public hearing with an agenda item that clearly identified the proposed amendment prior to approval of the projects by its authorized legislative body in accordance with Section 5(A) of the *TransNet* Extension Ordinance and Rule 7 of SANDAG Board Policy No. 31.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Santee, California, as follows:

Section 1. That the City of Santee requests that SANDAG make the following changes to its 2018 POP (the "Amendment"):

A. Revise the projects and amount of projected annual *TransNet* funding available for the Santee projects after bond debt service, the anticipated Road Maintenance and Rehabilitation Account (RMRA) revenue, and the projected Regional Transportation Congestion Improvement Program (RTCIP) anticipated funding as depicted on the revised Exhibit A – Table 1 attached to this Resolution and incorporated herein.

<u>Section 2.</u> That pursuant to Section 2(C)(1) of the *TransNet* Extension Ordinance, the City of Santee certifies that no more than thirty percent of its annual revenues shall be spent on local street and road maintenance-related projects.

<u>Section 3.</u> That pursuant to Section 4(E)(3) of the *TransNet* Extension Ordinance, the City of Santee certifies that all new or changed projects, or major reconstruction projects included in the Amendment and funded by *TransNet* revenues shall accommodate travel by pedestrians and bicyclists, and that any exception to this requirement permitted under the Ordinance and proposed was clearly noticed as part of the City of Santee's public hearing process for the Amendment.

<u>Section 4.</u> That pursuant to Section 8 of the *TransNet* Extension Ordinance, the City of Santee certifies that the required minimum annual level of local discretionary funds to be expended for street and road purposes will be met throughout the 5-year period consistent with the most recent Maintenance of Effort Requirements adopted by SANDAG.

<u>Section 5.</u> That pursuant to Section 9A of the *TransNet* Extension Ordinance, the City of Santee certifies that it will exact \$2,583.82 effective July 1, 2020 plus all applicable annual increases, from the private sector for each newly constructed residential housing unit in that jurisdiction (unless exempted under the *TransNet* Extension Ordinance,) and shall contribute such exactions to the Regional Transportation Congestion Improvement Program (RTCIP).

<u>Section 6.</u> That pursuant to Section 13 of the *TransNet* Extension Ordinance, the City of Santee certifies that it has established a separate Transportation Improvement Account for *TransNet* revenues with interest earned expended only for those purposes for which the funds were allocated.

<u>Section 7.</u> That pursuant to Section 18 of the *TransNet* Extension Ordinance, the City of Santee certifies that each project of \$250,000 or more will be clearly designated during construction with *TransNet* project funding identification signs.

Section 8. That the City of Santee does hereby certify that all applicable provisions of the *TransNet* Extension Ordinance and SANDAG Board Policy No.31 have been met.

<u>Section 9.</u> That the City of Santee agrees to indemnify, hold harmless, and defend SANDAG, the San Diego County Regional Transportation Commission, and all officers and employees thereof against all causes of action or claims related to City of Santee's *TransNet* funded projects.

<u>Section 10</u>. That the City of Santee amends the Local Street Improvement Program and amends the adopted Capital Improvement Program budget for *Transnet* funded projects.

ITEM TITLE NOTICE OF FUNDING AVAILABILITY AND WORKSHOP ON THE USE OF CARES ACT (CDBG-CV) FUNDING.

DIRECTOR/DEPARTMENT Melanie Kush, Development Services

SUMMARY On March 27, 2020, the President signed H.R. 748, known as the Coronavirus, Relief, and Economic Security (CARES) Act. The CARES Act provides an additional \$5 billion of Community Development Block Grant - Coronavirus (CDBG-CV) funds to rapidly prepare, prevent and respond to the Coronavirus Pandemic.

On April 2, 2020, the City received notification (Attachment 2) from the United States Department of Housing and Urban Development (HUD) that its CDBG-CV allocation will be \$162,104. Additionally, \$85,389 was allocated to Debt Service Reserve in Program Year (PY) 2019 which could be reallocated to COVID-19 response activities, if desired, bringing the total amount available to \$247,493. Based on communications with City staff currently involved in Coronavirus response activities, and also with several of the City's current subrecipients, the following four categories are options for funding:

- Increased Funding for Current Subrecipients Meal and food distribution, grocery delivery and homeless services:
- Micro-Enterprise Business Assistance (Grants/Forgivable Loans) Up to \$10,000 per micro-enterprise for retaining employees and sustaining operations;
- Emergency Rental Assistance (Limited to Three Months) Contract with a current local provider (e.g., CSA San Diego, Crisis House or HomeStart) to administer a rental assistance program.
- Administration & Planning (Maximum: \$34,420)
 Staff time, noticing, postage, office supplies.

NEXT STEPS: Based on the City Council's direction on funding allocations, staff will prepare a 2015-19 Consolidated Plan Amendment, if needed, a Program Year 2019 Annual Action Plan Amendment, and an Amendment to the Citizen's Participation Plan to incorporate COVID-19 related waivers, for the City Council's consideration at the next City Council meeting.

ENVIRONMENTAL REVIEW This item is exempt from environmental review under the California Environmental Quality Act ("CEQA") by CEQA Guidelines section 15061(b)(3) because the action does not have the potential for causing a significant effect on the environment.

FINANCIAL STATEMENT The City of Santee has been allocated \$162,104 in Program Year (PY) 2019 CDBG-CV funds and \$85,389 allocated to PY 2019 Debt Service Reserve could be reallocated to COVID-19 response activities, if desired, bringing the total amount available to \$247,493. The 15% cap on Public Service activities does not apply to these funds but up to 20% of the \$162,104 CDBG-CV allocation (\$32,420) may be used for "Administrative" activities.

NOTICE OF FUNDING AVAILABILITY AND WORKSHOP ON THE USE OF CARES ACT (CDBG-CV) FUNDING

CITY COUNCIL MEETING MAY 13, 2020

A. CDBG CV BACKGROUND

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law by President Trump on March 27, 2020, which included additional CDBG funds to assist communities across the United States in mitigating the impacts of COVID-19. These funds were allocated based on existing grant formulas and come with new guidance intended to allow quick action to assist low-income and vulnerable citizens impacted by COVID-19.

The CARES Act provides flexibilities for CDBG grantees to make it easier to use CDBG-CV, FY 2019-20, and FY 2020-21 CDBG grants for coronavirus response. Notably, the flexibilities granted are the immediate availability of a five-day public comment period (reduced from 30 days) for amendments and new plan submissions, and removal of the 15 percent CDBG public services funding cap to *prevent*, *prepare for*, *and respond* to the coronavirus pandemic. HUD has advised grantees to amend or prepare their plans as soon as possible, thus prompting the current request to provide direction on the distribution of these funds. The City received a letter from HUD (Attachment 2) dated April 2, 2020 indicating that it will be receiving \$162,104 in CDBG-CV funding. Additionally, \$85,389 in Program Year 2019 Debt Service Reserve funds could be allocated for Coronavirus response at the City Council's discretion, bringing the total amount available to \$247,493.

The proposed increases for the City's current subrecipients as included in the table were provided by the subrecipients based on dialogue with staff on the providers' and communities' needs in responding to COVID-19.

2. Micro-Enterprise Business Assistance (Grants/Forgivable Loans)

Under this program, Santee based micro-enterprise businesses (5 employees or less) could apply for low- or no-cost CDBG funded loans to small businesses that have been impacted by the Coronavirus pandemic. The goal would be to create and retain jobs for the community by stabilizing weakened businesses, encouraging business owners to re-open or expand their business. The grants/loans would be up to \$10,000 each. If selected, this would be a new program of the City of Santee that would be administered by City staff. Proposed Allocation: \$100,000

3. Emergency Rental Assistance (Limited to 3 Months)

This program would provide financial assistance to Santee residents who are in danger of becoming homeless due to their inability to pay their monthly rent. Assistance under this program would be limited to up to three months' rent payable directly to the landlord. This program would have eligibility requirements based on income and would likely be managed by a current non-profit provider through a request for proposal process. Potential providers include CSA San Diego, HomeStart and Crisis House. Proposed allocation: \$57,618

4. Administration and Planning

Based on the significant reduction in General Fund revenues the City is experiencing and significant amount of staff time needed to administer these new programs, staff recommends that the maximum of twenty percent (\$34,420) be allocated to this program to offset the direct costs incurred by the City.

C. NEXT STEPS

Following City Council's direction, the following steps would occur to allocate these funds.

Amend 2015-2019 Consolidated Plan – If the City Council opts to pursue an Economic Development-Micro Business Enterprise (Grant\Forgivable Loan) program the 2015-19 Consolidated Plan would be amended to add an Economic Development Goal.

Amend Program Year 2019 Annual Action Plan – HUD requires the preparation of an Annual Action Plan to describe how federal funds will benefit low income households. On April 24, 2019, the City Council approved the Program Year 2019 Annual Action Plan. HUD had recently provided guidance that jurisdictions should amend their current Annual Action Plans to allocate CDBG-CV and any available CDBG funds towards activities to prevent the spread of Coronavirus. The Amendment would focus on how the CDBG-CV and redirected CDBG funds would be used.

Based on direction provided at this City Council meeting, staff will prepare and notice an amendment to the PY 2019 Annual Action Plan for approval at the May 27, 2020 City Council Public Hearing.

<u>Amend Citizen's Participation Plan</u> - As required by HUD regulations, the City must have and follow a detailed Citizen's Participation Plan that specifies the City's policies and procedures for engaging and encouraging citizens to participate in creating, evaluating and implementing the CDBG program.

To facilitate rapid distribution of funds in response to the to COVID-19, and as authorized by HUD waivers, staff will prepare and notice an amended Citizen and Community Participation Plan (CCPP) for approval at the next City Council meeting on May 27, 2020. Expedited procedures included in the amended CCPP include the notice and reasonable opportunity to comment of no less than five days and to host virtual public hearings in accordance with national, state and local health authorities' direction.

D. **RECOMMENDATION**

Consider funding options and provide direction to staff.

Dear Mayor Minto:

I am pleased to inform you of a special allocation to your jurisdiction of Community Development Block Grant funds to be used to prevent, prepare for, and respond to the coronavirus (COVID-19). This allocation was authorized by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, which was signed by President Trump on March 27, 2020, to respond to the growing effects of this historic public health crisis.

The CARES Act made available \$5 billion in Community Development Block Grant Coronavirus (CDBG-CV) funds. Of this amount, the Department is immediately allocating \$2 billion based on the fiscal year 2020 CDBG formula. The remaining \$3 billion shall be allocated based on needs using best available data, in the following tranches: \$1 billion shall be allocated to States and insular areas within 45 days of enactment of the Cares Act, and \$2 billion shall be distributed to states and local governments at the discretion of the Secretary. Up to \$10 million will be set aside for technical assistance. Given the immediate needs faced by our communities, the Department has announced the first allocation of funds. Your jurisdiction's allocation is \$162,104.

The CARES Act adds additional flexibility for both the CDBG-CV grant and, in some cases, for the annual FY2020 CDBG grants in these unprecedented times. The public comment period is reduced to not less than 5 days, grantees may use virtual public hearings when necessary for public health reasons, the public services cap is suspended during the emergency, and States and local governments may reimburse costs of eligible activities incurred for pandemic response regardless of the date.

In addition, the CARES Act authorizes the Secretary to grant waivers and alternative requirements of statutes and regulations the Secretary administers in connection with the use of CDBG-CV funds and fiscal year 2019 and 2020 CDBG funds (except for requirements related to fair housing, nondiscrimination, labor standards, and the environment). Waivers and alternative requirements can be granted when necessary to expedite and facilitate the use of funds to prevent, prepare for, and respond to coronavirus.

The Department is developing a notice that will further describes the CARES Act's provisions, a Quick Guide to the CARES Act flexibilities and other provisions, and other resources to enable swift implementation of CDBG-CV grants. As these become available, they will be

posted on HUD's website and distributed to grantees. The Department will also support grantees with technical assistance.

As you develop your plan for the use of these grant funds, we encourage you to consider approaches that prioritize the unique needs of low- and moderate—income persons and the development of partnerships between all levels of government and the private for-profit and non-profit sectors. You should coordinate with state and local health authorities before undertaking any activity to support state or local pandemic response. CDBG-CV grants will be subject to oversight, reporting, and requirements that each grantee have adequate procedures to prevent the duplication of benefits. HUD will provide guidance and technical assistance on DOB and regarding prevention of fraud, waste, and abuse and documenting the impact of this program for beneficiaries.

The Office of Community Planning and Development (CPD) is looking forward to working with you to successfully meet the urgent and complex challenges faced by our communities. SUMMARY

In response to the economic effects of the novel coronavirus outbreak (COVID-19) on the Santee community and local businesses, the City of Santee has initiated a "Support Our Santee" (SOS) Program to mitigate economic hardships as a result of business closures, widespread unemployment, and disruption of the local economy and social services. The City has already taken proactive steps to protect the community and assist businesses and residents in accessing federal and state programs, and the further actions are proposed as part of this Program

The purpose of the "Support Our Santee" Program is to provide relief and assistance to residents and businesses experiencing hardships as a result of the economic impacts of COVID-19. The Program outlines specific goals, and actions for a communitywide response to this unprecedented crisis.

Three specific actions are recommended for the Council's consideration to provide economic relief to Santee businesses, including: 1) Waiver of Business License Late Payment Penalties; 2) TOT Deferral Program; and 3) Rental payment adjustments for City lessees and concessionaires, specifically Sportsplex USA, and Riverwalk Grill, as outlined further in the Staff Report.

ENVIRONMENTAL REVIEW

This action is not a project and is exempt from the California Environmental Quality Act ("CEQA") as defined in Section 15378 of the CEQA Guidelines.

FINANCIAL STATEMENT

Payment deferrals will result in a delay in receipt of payments, but will have a neutral effect on total revenues. The proposed rent adjustments for Sportsplex USA and Riverwalk Grill will reduce anticipated revenues for the current fiscal year by approximately \$86,000.

"SUPPORT OUR SANTEE" PROGRAM TO ADDRESS FISCAL IMPACTS FROM NOVEL CORONAVIRUS (COVID-19) CITY COUNCIL MEETING MAY 13, 2020

A. BACKGROUND

On March 4, 2020, the State of California declared a state of emergency in response to the global spread of the novel coronavirus (COVID-19). This was followed by an order of the San Diego County Health Officer on March 12, 2020 establishing social distancing and visiting restrictions countywide, and banning mass gatherings. On March 16, 2020, the Governor issued a stay at home order instructing all individuals living in the State of California to stay home or at their place of residence, except as needed to maintain continuity of operations of essential critical infrastructure sectors. All businesses that did not meet the definition of essential business were considered "non-essential businesses" and were ordered to remain closed for the duration of the public health order. The San Diego Health Officer also issued health orders and emergency regulations that provided additional directives relating to social distancing guidelines and required closures or modified levels of service for many businesses. The City of Santee declared a local emergency on March 18, 2020 and a proclamation of local emergency on March 25, 2020.

These public health directives were issued to address the spread of the coronavirus, but they have resulted in significant hardship to several sectors of the community, and particularly small businesses. Restaurants and other food establishments have been required to close all on-site dining, and all food service has been limited to delivery, pick-up, or drive thru. Other essential businesses have also been required to modify their operations for social distancing, and to invest in additional protections for their employees and customers. Businesses deemed non-essential, such as gyms, hair and nail salons, specialty retail and services, and various commercial and industrial businesses, have ceased operations entirely since mid-March. This month, both the State and County are implementing new guidelines for a phasing of gradual business re-openings, with modified operations, and that will present new challenges for business operations.

Business closures and limited operations have resulted in massive furlough and lay-offs. According to a recent SANDAG study, it was estimated that 400,000 have lost their jobs countywide since March 7th, and countywide unemployment in late April reached an all-time high of 26.8%. Every household in Santee has been affected in some way by this global crisis. The most vulnerable sectors of the community have been especially hard hit, such as seniors and the disabled, lower income households, and homeless individuals.

The City of Santee has initiated a "Support Our Santee" (SOS) Program to mitigate economic hardships in the Santee community as a result of business closures, widespread unemployment, and disruption of the local economy and social services. The City has already taken proactive steps to protect the community and assist businesses and residents in accessing federal and state programs, and the "Support Our Santee" Plan outlines specific goals and strategies for a communitywide response to this unprecedented crisis.

B. "SUPPORT OUR SANTEE" PROGRAM

The purpose of the "Support Our Santee" Program is to provide relief and assistance to residents and businesses experiencing hardships as a result of the economic impacts of COVID-19. The following goals and actions have been outlined for this program.

Goal 1: Provide economic relief and support to Santee businesses and residents

Specific Actions:

- On March 25, 2020, the Santee City Council declared a temporary moratorium on evictions for non-payment of rent by residential tenants impacted by the COVID-19 crisis, two days prior to the State issuing additional eviction protections. The City responded on April 8, 2020 with an urgency ordinance incorporating the State provisions, and expanding the temporary moratorium on evictions for non-payment of rent to also include commercial tenants.
- The City has provided technical assistance to businesses and referrals to the East County Small Business Development Center (SBDC) offices for specific guidance. The City's webpage has also provided direct links to federal, state and local assistance programs for both businesses and residents.
- In collaboration with the Santee Chamber of Commerce, the City has posted a list of restaurants and other essential businesses that are remaining in operation to serve local customers, while adhering to public health directives limiting and modifying their scope of operations.
- Since mid- to late March, the City has suspended parking citation fines, and Stormwater late payment fees.
- Consider the waiver of Business License late payment penalties for local businesses.
 Waiver of Business License Late Payment Penalties

With the current business closures and reduced operations, about 100 Santee-based businesses and over 70 home occupation businesses have not renewed their business license for licenses that expired so far in 2020. The City has a monthly \$15.50 penalty for late payment of a business license renewal. City staff is recommending the City Council to consider formally waiving business license late payment penalties for local businesses until they are able to re-open and operate at a reasonable level.

- Consider a micro-lending program for a limited number of impacted micro-enterprise businesses, funded from the supplemental Community Development Block Grant CDBG-CV funding.
- Goal 2: Establish a dialogue with the Santee business community and other critical sectors to provide feedback on steps to mitigate economic impacts

Specific Actions:

- In the absence of the ability to physically meet with businesses, Mayor Minto formed a Blue Ribbon Committee working group comprised of business representatives and community stakeholders to provide to himself and Vice Mayor Koval feedback on economic impacts and future steps to transition to reopening businesses.
- The Mayor's Blue Ribbon working group held its first meeting on April 24, 2020, and has been communicating regularly under the leadership of Vice Mayor Koval as a way to stay in touch with various businesses and their issues.

Goal 3: Provide economic relief to Santee's hospitality industry, City lessees and concessionaires

Specific Actions:

 Consider a deferral program for the payment of Transient Occupancy Tax (TOT) to provide interim relief to Santee's four hospitality/lodging operators (including Santee Lakes) as needed.

TOT Deferral Program

The Governor's "Stay at Home" order and State and County travel restrictions have caused a devastating impact on the hospitality industry. Santee's local hotels have either temporarily closed and furloughed their employees or are operating at substantially reduced occupancy rates. To address these economic impacts, City staff is recommending the City Council consider allowing Santee's four hotel/motel/lodging operators (including Santee Lakes) to defer the payment of Transient Occupancy Tax (TOT) for the quarters ended March 31 and June 30. Three of the City's four lodging operators have paid their TOT for the quarter ended March 31, and the other has requested the City consider a payment deferral. Several operators have expressed the potential need for a payment deferral for the current quarter ending June 30. As structured, the TOT Deferral program would require that all taxes due for the current fiscal year would be received by August 31, 2020 in order for penalties and interest to be waived and would thus make this revenue available to be recognized by the City in FY 2019-20. The TOT Deferral program would be structured as follows:

90-day deferral for payment of TOT collected, quarter ended March 31, 2020 Deferral request must be submitted in writing

TOT Deferral Agreement to be executed

TOT return must be filed with the City by May 15, 2020

Waiver of penalties and interest if paid in full by July 31, 2020

Penalties and interest will be assessed retroactively to April 30, 2020 if TOT is not paid in full by July 31, 2020

30-day deferral for payment of TOT collected, guarter ended June 30, 2020

Deferral request must be submitted in writing

TOT Deferral Agreement to be executed

TOT return must be filed with the City by July 31, 2020

Waiver of penalties and interest if paid in full by August 31, 2020

Penalties and interest will be assessed retroactively to July 31, 2020 if TOT is not paid in full by August 31, 2020

 Consider providing rent adjustments for key City lessees and concessionaires, specifically Sportsplex USA and the Riverwalk Grill.

Rental Payment Adjustments for City Lessees and Concessionaires

Two local businesses operate as lessees and concessionaire under contract to the City, and both have requested rent adjustments due to economic hardship. City staff is requesting consideration of the following rent adjustments for these businesses:

Sportsplex USA: Under an agreement for facility maintenance and operations, Sportsplex USA is required to pay the City fixed monthly rent and a share of facility revenues. In light of "Stay at Home" orders and the resulting suspension of operations at Sportsplex, staff recommends that the City Council consider waiving payment of fixed monthly rent and providing a credit of \$1,000 per week for ongoing maintenance performed by Sportsplex while the facility remains closed. Staff further recommends that payment of revenue-sharing amounts for the Sportsplex Program Year ended May 31, 2020 currently payable to the City by July 31, 2020 be postponed until monthly gross revenue exceeds 80% of pre-pandemic revenue or January 1, 2021, whichever shall occur first, and then repay the deferred payments over a period of twelve months.

Riverwalk Grill: The operator of the Riverwalk Grill also makes revenue-sharing payments to the City, as well as paying for utility expenses associated with the facility. Staff recommends that the City Council consider waiving utility expense payments until Riverwalk Grill has reopened.

Goal 4: Provide additional support to households experiencing extreme hardship and augment funding to social service agencies supporting vulnerable segments of the community

Specific Actions:

- Consider a Rent Assistance program for Santee residents on the brink of homelessness due to inability to pay rent and utilities. This would be funded from the supplemental CDBG-CV funding.
- Consider allocating CDBG-CV funding to provide additional funding for current CDBG subrecipients providing critical support and social services to vulnerable populations within the community experiencing extreme hardship. These social services providers would include Crisis House, Elderhelp of San Diego, Meals-On-Wheels, Santee Food Bank, and Santee Santas Foundation.
- Goal 5: Assist businesses with guidance on re-opening and resuming operations, and implementing the directives outlined by State and County Health Officials

Specific Actions:

- Continue to assist businesses towards re-opening operations with guidance for specific industries, pursuant to the new directives outlined by State and County Health Officials.
- Provide technical assistance to businesses in implementing the new directives, and resuming their business operations.

SUMMARY

At present, the Mayor and members of the City Council are not subject to term limits. However, an initiative measure has qualified for the November 3, 2020 General Municipal Election that, if adopted, would establish a three term lifetime limit of Council service as either the Mayor or as a City Councilmember (not three terms for each office). The measure would also count any partial term served as a full term.

The City Council has requested a briefing from the City Attorney on the general law related to term limits. This briefing will allow the City Council to consider the issues involved with term limits and provide direction to the City Attorney, if so desired. This report provides the City Council with a summary of the general law related to term limits. During the workshop, it is anticipated that the City Council will provide direction regarding any additional steps the Council wishes to take related to term limits.

This action is exempt from the requirements of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15061(b)(3).

FINANCIAL STATEMENT Im

REPORT AND WORKSHOP ON LEGAL ISSUES ASSOCIATED WITH TERM LIMITS

A. GENERAL LEGAL BACKGROUND

In California, the legal issues associated with term limits are governed by Government Code section 36502(b) and the Federal and California Constitutions, as interpreted by the courts. While Section 36502(b) and the Federal and California Constitutions impose certain constraints on term limits, the law generally provides a wide range of options for local jurisdictions to adopt term limits that best fit the needs of the community.

The California Supreme Court has found that term limits, including ones containing lifetime bans, are consistent with both the Federal and California Constitutions when they satisfy certain protections. (*Legislature v. Eu* (1991) 54 Cal.3d 492.) Such measures are consistent with constitutional requirements when they: (1) allow the voters the right to vote for any other qualified candidates; (2) allow the person subject to the term limit to run for other public office; (3) provide a sufficient period of service before term limits apply; and (4) apply prospectively only.

In 1993, a lower California Court applied these criteria to uphold a term limit contained in the City Charter of the City of Redondo Beach. (*Cawdrey v. City of Redondo Beach* (1993) 15 Cal.App.4th 1212.) The City Charter provided that a person could only serve two terms, whether consecutive or not. When a council member tried to run for a third term, he was denied by the City Clerk and a local voter sued, contending that the term limit in the City Charter violated the California and Federal Constitutions and was preempted by state law. The Court of Appeal applied the factors identified by the California Supreme Court and upheld the term limit. In addition, the Court of Appeal found that charter cities had the right to obtain such term limits, noting that "imposing term limits upon the City's mayor and council members is a municipal affair within the authority granted to the City" by the California Constitution.

After the *Cawdrey* decision, the Legislature enacted Government Code section 36502(b) to clarify that both charter and general law cities have the authority to impose local term limit measures through voter approval. Section 36502(b) also contains the specific requirement that term limits may only apply prospectively, one of the key factors identified by the California Supreme Court as being necessary to maintain consistency with the Federal and State Constitutions. Therefore, a local term limit measure must comply with Government Code section 36502(b) and meet the other factors identified by the California Supreme Court in the *Eu* case to satisfy constitutional requirements.

Proposals to enact term limits for elected city officials, including consecutive or lifetime term limits, may be brought forward for consideration either by a citizens' initiative petition or through City Council action, but in either case must be approved by a majority

of voters voting on the measure. (Government Code section 36502(b)). In the November 2020 election, Santee voters will have the opportunity to consider one version of a term limit measure brought forward by a citizens' initiative petition.

B. TERM LIMITS INITIATIVE MEASURE ON THE NOVEMBER BALLOT

At present, the Mayor and Councilmembers are not subject to term limits. However, a term limits initiative measure has been placed on the upcoming General Municipal Election on November 3, 2020, which would establish a three term lifetime limit of Council service as either the Mayor or as a City Councilmember (not three terms for each office). More specifically, if adopted, the measure would require that no person serve as an "Elected Official," defined to include both Mayor and Members of the City Council, for more than twelve years, or three terms, whichever is less. Further, any portion of a term, whether by election or appointment, would count as a full term.

If adopted, the measure would apply to terms starting in November of 2020, as required by Government Code section 36502(b). As noted above, both Section 36502(b) and the California Supreme Court have determined that term limits may only apply prospectively. If adopted, the measure could only be amended or repealed by another majority vote at a City election.

C. TERM LIMITS IN OTHER JURISDICTIONS IN SAN DIEGO COUNTY

Several other jurisdictions in San Diego County have term limits. The details of the term limits in other San Diego County jurisdictions vary. Some have lifetime service limits, some consecutive term limits, and some even have a combination of both lifetime and consecutive term limits. In contrast to a lifetime term limit, a consecutive term limit requires a "cooling off" period after serving a number of consecutive terms during which time a person may not serve on the Council or as Mayor. After the prescribed "cooling off" period, a person may again run and serve as a member of Council or as Mayor for another set of consecutive terms.

Both the City and County of San Diego have adopted lifetime service limits.

- <u>City of San Diego</u>. In November 2018, Measure K was adopted by City of San Diego voters to provide that "no person shall serve more than two four-year terms as a Council member. If for any reason a person serves a partial term as Councilmember in excess of two (2) years, that partial term shall be considered a full term for purposes of this term limit provision." (City of San Diego Charter, Article III, Section 12(c)).
- County of San Diego. Similarly, in June 2010, Measure B was approved by County voters that limits the terms of the Board of Supervisors to two four-year terms. It specifically states: "(a) No person may serve for more than two terms as Supervisor, regardless of district represented, after the

effective date of this section. (b) Any person who is elected or appointed to an unexpired term as a Supervisor after the effective date of this section and who serves more than one-half of a full term of office shall be deemed, for the purposes of this section, to have served a full term; [and] (c) Any Supervisor who resigns or is removed from office with less than one-half of a full term remaining until the expiration of the term shall be deemed, for the purpose of this section, to have served a full term." (County of San Diego Charter, Section 401.5).

Alternatively, the City of Chula Vista provides a consecutive term limit for the members of Council and Mayor.

City of Chula Vista. In Chula Vista, "[n]o person shall be eligible for nomination and election to the office of City Councilmember or Mayor for more than two (2) consecutive terms, and no person who has held a Council office for a period of two (2) consecutive terms or the office of Mayor for two (2) consecutive terms, may again seek nomination and election to said offices of Council or Mayor respectively until a period of one (1) year from the termination of the second term for Councilmember or Mayor has elapsed; provided, however, that any person who is appointed by the Council to fill the office of Councilmember or Mayor may not seek nomination and election to said offices of Councilmember or Mayor until a period of one year from the termination of the appointed term has elapsed. Said appointee shall be eligible to seek nomination and election for two (2) full terms thereafter. Any person elected in a special election for the balance of a regular term of Mayor and/or Councilmember for a period of two (2) years or less may seek nomination and election for two (2) full terms thereafter." (Chula Vista City Charter, Section 300(C)).

National City limits both consecutive terms of office for certain elected city officials and provides for a lifetime term limit for all elected offices combined.

• National City. In June of 2018, voters approved an ordinance that provides: "no person shall be eligible for nomination and election to serve in the offices of members of the city council ... for more than three consecutive terms in the same elected office, and no person who has held the office of member of the city council... for three consecutive terms may again seek nomination and election to the same elected office until one election following the termination of the third term in that same elected office has elapsed." (National City Municipal Code section 2.73.010). Further a lifetime term limit was adopted so that, "no person shall be eligible for nomination and election to serve in any elective city office ... for more than six terms in all elected offices combined." (National City Municipal Code section 2.73.020).

D. AUTHORITY TO PROPOSE AN ALTERNATIVE MEASURE TO THE INITIATIVE

Government Code section 36502(b) provides that proposals to enact term limits may be brought forward for consideration either by a citizens' initiative petition or through City Council action. Therefore, the City Council may propose an alternative term limits measure at the November 3, 2020 Election to Santee voters. (Government Code section 36502(b); Elections Code section 9222).

If two measures are proposed at the same election that have conflicting terms, they are deemed to be "competing measures". In such a case, Elections Code section 9221 provides that should both measures pass with a majority, "the ordinance receiving the highest number of affirmative votes shall control." Therefore, for example, if the petition initiative measure were to receive 57% voter approval and the Council's alternative measure received 59% approval, the Council's alternative measure would become the operative law of the City.

The City Council will have until Friday August 7, 2020 to place such a measure on the November 3, 2020 ballot. If the City Council wishes to pursue such a measure, it is recommended that the Council provide direction on the components of such a measure and the City Attorney will prepare a draft measure for Council's consideration at an upcoming City Council meeting.
