(22) City Council Consideration of an Urgency Ordinance Extending the Temporary Moratorium on Evictions Due to Nonpayment of Rent by Residential and Commercial Tenants Impacted by the Novel Coronavirus (COVID-19) and Setting Forth the Facts Constituting Such Urgency. (City Manager – Best)

The City Manager presented the staff report and responded to Council questions.

## **PUBLIC SPEAKERS:**

Rob Schick

Mayor Minto inquired whether the State of California had changed its regulations on temporary moratoriums for evictions to match or exceed the current City Ordinance, to which the City Manager responded in the affirmative; he stated the original purpose of this Ordinance was to allow citizen to get assistance if needed and that the City should now rely on the State since the issues are covered.

Vice Mayor Koval concurred with Mayor Minto and added the City has funds available through the CARES Act; she stated that residents are covered for 180 days of forbearance through the CARES Act; she mentioned that the City should step back, since residents are covered at both the State and Federal level.

Council Member McNelis stated the City adopted the Ordinance as a safety net to fill in spaces that State laws were missing; he added that State laws are now more inclusive to the local concerns Council has; he concurred it is time to rely on the State.

Council Member Houlahan stated the Ordinance should be adopted and be continued by City staff; he expressed concerns for relying on the State as residents could fall through the cracks; he stated the Ordinance is a good safety net and could be automated at the staff level.

Council Member Hall stated rules from the State are in place and that the City could bring the Item back if needed; he expressed concerns for businesses being able to operate.

**FAILED MOTION:** Council Member Houlahan moved to adopt the Ordinance.

The motion failed for lack of a second.

**ACTION:** Mayor Minto moved to not adopt the Ordinance and sunset the temporary moratorium on evictions, effective July 31, 2020.

Council Member McNelis seconded the motion, which carried by the following roll call vote: Mayor Minto: Aye; Vice Mayor Koval: Aye, and Council Members Hall: Aye; Houlahan: No, and McNelis: Aye. Ayes: 4. Noes: 1.

Vice Mayor Koval reported she attended the East County Economic Development Council meeting; she thanked the City staff for the 4<sup>th</sup> of July fireworks display; she attended the White House phone call related to the pandemic and will provide a full report to the Council at a later date.

Mayor Minto reported attending the San Diego Association of Governments (SANDAG) meeting in which the Regional Housing Needs Assessment was discussed, he stated several appeals by other Cities were turned down and the City of San Diego called for a weighted vote; he stated he is in opposition of weighted votes that cause a lack of representation; he also thanked staff for the 4<sup>th</sup> of July fireworks display.

Council Member Hall stated Coronado may bring litigation against SANDAG in relation to

the vote.

## **CITY MANAGER REPORTS:**

The City Manager commented on the 4<sup>th</sup> of July fireworks display and thanked the Community Services Department for their efforts; she expressed gratitude to Chief Stuber for his years of service to the City; she stated the City has day camp programs available for youth; she announced the City has created different ways to help businesses during the pandemic, as well as residential support for individuals, and stated the information is available on the City website.

## **CITY ATTORNEY REPORTS:**

The City Attorney announced, in relation to the updated Municipal Code, the independent election counsel for the November 3, 2020, election has been selected; he clarified the process in which complaints would be handled.
