ITEM TITLE APPROVAL OF READING BY TITLE ONLY AND WAIVER OF READING IN FULL OF ORDINANCES AND RESOLUTIONS ON THE AGENDA; FINDING THE ACTION IS NOT A PROJECT SUBJECT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT ("CEQA")

### SUMMARY

This Item asks the City Council to waive the reading in full of all Ordinances on the Agenda (if any) and approve their reading by title only. The purpose of this Item is to help streamline the City Council meeting process, to avoid unnecessary delay and to allow more time for substantive discussion of Items on the agenda.

State law requires that all Ordinances be read in full either at the time of introduction or at the time of passage, unless a motion waiving further reading is adopted by a majority of the City Council. (Gov. Code, § 36934). This means that each word in each Ordinance would have to be read aloud unless such reading is waived. Such reading could substantially delay the meeting and limit the time available for discussion of substantive Items. Adoption of this waiver streamlines the procedure for adopting the Ordinances on tonight's Agenda (if any), because it allows the City Council to approve Ordinances by reading aloud only the title of the Ordinance instead of reading aloud every word of the Ordinance.

The procedures for adopting Resolutions are not as strict as the procedures for adopting Ordinances. For example, Resolutions do not require two readings for passage, need not be read in full or even by title, are effective immediately unless otherwise specified, do not need to be in any particular format unless expressly required, and, with the exception of fixing tax rates or revenue amounts, do not require publication. However, like Ordinances, all Resolutions require a recorded majority vote of the total membership of the City Council. (Gov. Code § 36936).

### SUMMARY

Staff recommends the City Council award the construction contract for the CDBG Pedestrian Ramp Improvements (CIP 2023-07) Project ("Project") to Portillo Concrete, Inc. in the amount of \$299,400.00. This Project will install Americans with Disabilities Act ("ADA") compliant pedestrian ramps at 40 locations across the City. These pedestrian ramp installations are part of a Citywide effort to improve accessibility in communities and to serve elderly and disabled people, which generally have been low- and moderate-income persons. The attached project map identifies the locations where a pedestrian ramp will be installed.

In compliance with the City's purchasing ordinance, Santee Municipal Code Section 3.24.100, City staff administered a formal bid process on January 24, 2023. Then on February 16, 2023, the City Clerk publicly opened and examined seven sealed bids. Upon review of the submitted bids, the bid submitted by Portillo Concrete, Inc. was determined to be the lowest responsive and responsible bidder in the amount of \$299,400.00. The bid submitted by Portillo Concrete, Inc. is 20% lower than the Engineer's construction estimate of \$360,000.00.

Staff also requests authorization for the City Manager, Director of Development Services or City Engineer to approve change orders in a total amount not to exceed \$74,850.00 (25% of the contract price) for unforeseen items and additional work associated with the Project. This will allow the City to complete additional installations in a single contract to provide cost savings for engineering design and construction administration.

#### SUMMARY

In July 2022, a purchase order in the amount of \$25,000 was issued to Border Tire, for FY 22/23 for as-needed tires and related services per the OMNIA Contract #2019209.

Due to the large amount of replacement tires that have been required this fiscal year and the dramatic escalation in tire pricing, a change order adding \$15,000 is required to cover costs for the remainder of FY 22/23 (through June 30, 2023); therefore, a purchase order change order is needed to increase the purchase order to \$40,000.

Santee Municipal Code (SMC) Section 3.24.180 authorizes the City to purchase equipment and supplies from a vendor at a price established by competitive or competitively negotiated bid by another public agency as long as that bid substantially complied with the formal bidding procedures in SMC Section 3.24.100. In November 2019, OMNIA (through the City of Mesa, Arizona) conducted a competitive process, substantially complying with Santee's Municipal Code, for procurement of tires, tubes and related services. Based on the requirements for the lowest responsive responsible bidders demonstrating the ability to meet certain quality and service requirements (including authorized dealer networks), the contract was awarded to Michelin. Border Tire is an authorized dealer under this contract, which has been extended through November 30, 2024.

SMC Section 3.24.180 requires City Council approval of all purchases exceeding \$25,000. Staff requests approval to issue a purchase order change order to Border Tire for an amount not to exceed \$15,000 to cover as-needed tire replacement costs for the remainder of FY 22/23, which will increase the total FY 22/23 purchase order amount to \$40,000.

#### SUMMARY

In response to incidents of hate speech and displays of symbols of hate and racism within the City, on June 24, 2020, the City Council approved Resolution No. 066-2020 reaffirming its commitment to combatting hate crime and to equitably serving and protecting all community members. The City Council resolved to work through the City's Community Oriented Policing Committee ("COMPOC"). COMPOC convened a DEI ad hoc subcommittee to develop a work plan.

On January 13, 2021, City Council approved and adopted the proposed Diversity, Equity and Inclusion Phase I Roadmap. The following actions were accomplished through this guiding document:

- April 19, 2021: Public meeting to provide update on City's and Sheriff Department's efforts to address diversity, equity, and inclusion internally and in the community.
- August 31 September 9, 2021: Needs assessment survey conducted by BW Research Partnership.
- November 2, 2021: Townhall meeting was held.
- March 1, 2022: Community values workshop was held.
- Summer 2022: COMPOC's DEI ad hoc subcommittee conducted core community values survey online and at Santee events.

The above actions culminated in the development of the Santee Core Community Values Statement, which identify the following values as foundational to the practice of valuing every individual:

- Accountability
- Community-minded
- Respect

COMPOC approved the community values on January 9, 2023. The COMPOC e requests the City Council approve and adopt the proposed Santee Core Community Values Statement, direct the City Manager to address and implement next steps for continuing these efforts, and provide any further direction to staff.



#### SUMMARY

On December 8, 2021, the City selected the M.W. Steele Group, Inc. ("M.W. Steele") to provide professional services relating to the Arts & Entertainment District Overlay Expansion Project ("Project"), as well as the preparation of a corresponding Program EIR with a total budget of \$400,000. The expansion of the Arts and Entertainment Overlay District is among the current priorities of the City Council to further enhance and guide development within the Town Center and proximate commercial areas. After entering into an agreement with the City in January 2022, M.W. Steele initiated essential first tasks for the Project, including creating an updated vision plan for the Arts & Entertainment District ("visioning") and defining a new District boundary. Both tasks involved extensive public outreach and engagement, including an online survey, pop-up outreach booths at three City events, and two community workshops that culminated in a workshop before City Council on August 24, 2022, where the Council selected an expanded Arts & Entertainment District boundary and directed Staff to explore options for enhancing uses in proximate commercial areas outside of this selected boundary.

During the months the visioning and boundary definition tasks for the Arts & Entertainment District Expansion were underway, Staff applied for and received two San Diego Association of Governments (SANDAG) grants related to the Town Center Specific Plan area: a Housing Acceleration Program (HAP) grant for \$264,000 and Smart Growth Incentive Program (SGIP) grant for \$400,000. The HAP grant funds the preparation of an Environmental Impact Report (EIR) for the Town Center Specific Plan Update, specifically to cover future multifamily and mixed-use housing development within the Town Center. Completion of an EIR would allow for streamlining of development within the Town Center by allowing future development consistent with the Town Center Specific Plan to tier-off of the EIR. The SGIP grant funds an update to the Santee Town Center Specific Plan, including updating goals, policies, and objectives as well as to tables, charts and graphics. The SGIP grant also augments existing efforts to expand the Arts & Entertainment District boundaries and promote new development within the District, including mixed-use housing, specialty commercial, and other entertainment uses. With the SGIP grant, Staff was able to leverage the existing City allocation for the Project and receive matching funds.

The receipt of these two SANDAG grants for the Town Center area represents an opportunity to consolidate the goals and objectives related to the Arts & Entertainment District Expansion Project with those of the grants. Staff has coordinated with M.W. Steele and SANDAG to formulate a consolidated approach that would result in a comprehensive update to the entire

Town Center Specific Plan and expanded Arts & Entertainment District, while adhering to the approved grant activities as required by SANDAG. This consolidated effort would also allow for enhanced uses in proximate areas outside of the boundaries of the Arts & Entertainment District. Both grants and the City-funded efforts have extensive overlap in tasks related to the preparation of a Program EIR. M.W. Steele has revised their proposed Scope of Services (attached) to reallocate City funds from environmental review tasks to tasks related to the preparation of Town Center Specific Plan and Arts & Entertainment District land use plans, site plans, landscape plans, graphics and the development design and development standards ("plan making"). Meanwhile, the two SANDAG grants would support activities primarily focused on the preparation of the Program EIR and technical documents, but also support plan making activities, such as the preparation of a Comprehensive Sign Program for the Town Center and Arts & Entertainment District. As part of this revised scope, Staff would manage public outreach and engagement, including the presentation of plan alternatives at five community workshops (one in each Council district and one at large) and three subsequent City Council workshops where Council would ultimately adopt a draft plan. The revised Scope of Services timeline would provide for Council adoption of a draft plan by September 2023. The adopted draft plan would, in turn guide the preparation of the corresponding Program EIR, with certification of a Final EIR and adoption of a new Town Center Specific Plan anticipated by September 2024. The adopted plan and Program EIR would then allow for streamlined development of projects consistent with the plan, with the goal of helping a vibrant Arts & Entertainment District to materialize.

#### **ENVIRONMENTAL REVIEW**

This amendment is not subject to the California Environmental Quality Act (CEQA) because it is not a "project" per Public Resources Code section 21065 and section 15378 of the CEQA Guidelines as it would not result in a physical change in the environment. The Project CEQA documents will be circulated for public review and input and presented to the City Council for approval at a later date.

FINANCIAL STATEMENT

Funding for this project was included the Planning Department's Fiscal Year 2021-22 Operating Budget. An additional appropriation would not be required for the revised agreement. The current agreement with M.W. Steele is for \$400,000. Combined with the HAP and SGIP grants, respectively \$264,000 and \$400,000, and excluding a \$40,000 allocation from the SGIP grant for City administrative time, the total revised agreement amount is \$1,024,000.

## CITY COUNCIL MEETING MARCH 8, 2023

#### A. BACKGROUND:

The Santee Town Center Specific Plan was approved by the City Council in 1986 and initially comprised 706 acres of property located north of Mission Gorge Road, south of Mast Boulevard, east of Mast Park, and west of Magnolia Avenue. The Specific Plan was adopted for the City's core area and is comprised of a mixture of land uses including undeveloped land and the San Diego River corridor. The Specific Plan has been amended several times over the years to accommodate various land use proposals and revisions, with the most recent revisions associated with the adoption of an Arts & Entertainment District Overlay and the approval of the Housing Element Rezones Implementation Project where the current Town Center Land Use Plan was adopted (Exhibit A). The initial vision of the City was to promote the development of a Town Center including retail commercial, offices, civic, recreational and other land uses to establish a focal point for the City. This vision continues with the proposed expansion of the Arts & Entertainment District, the purpose of which is to support tourism and attract commercial, educational and recreational uses that beautify and enliven the Town Center.

Fostering the development of a vibrant Arts & Entertainment District ("District") has been and continues to be a Council priority. Steps to create such a District began with a first public workshop held by the City Council on August 14, 2019 on the concept of an Arts & Entertainment Overlay District, conceived to promote a concentration of arts, cultural and entertainment-oriented uses within the Town Center area. At the workshop, the City Council directed staff to move forward with the creation of the Arts & Entertainment Overlay District. The Arts & Entertainment District Overlay was subsequently adopted by the City Council on December 11, 2019. The Overlay District captures existing and planned land uses within a 155-area of the Town Center, including the Santee Trolley Square Commercial Center and approved Karl Strauss Brewery, as well as, the movie theater and hotel that are proposed within the boundaries of the Overlay District. The proposed movie theater and hotel land uses will support other nearby land uses within the Specific Plan in that they would provide a customer base for restaurant and retail uses, as well as place visitor-accommodating services in an area accessible to public The Overlay District also includes streets and public paths/trails where street fairs and other special events could be hosted. The currently adopted Arts & Entertainment Overlay District boundary is shown in Exhibit B.

The establishment of the Arts & Entertainment Overlay District eliminated the Conditional Use Permit (CUP) requirement for certain listed uses, including cabarets, farmer's markets, resort hotels, motels, community theaters, libraries and craft production within the boundaries of the Overlay District. The District also established brewpubs, wineries, sports bars, indoor and outdoor recreation venues, street fairs and farmer's markets as permitted commercial uses. Additionally, the maximum permitted commercial building height was set at 55 feet, consistent with the height provisions of the RiverView Office Park Overlay and Urban Residential (R-30) multifamily residential development allowed in the Town Center. Special sign standards were also adopted to promote thematic and iconic sign designs within the District.

#### B. **PROJECT DESCRIPTION:**

Recognizing the opportunity to foster development and activate additional areas within and proximate to the Town Center in accordance with the Arts & Entertainment vision, the City Council made it a priority to expand the District. Following this Council priority, on September 24, 2021 Staff issued a Request for Proposals for consultant work on the Arts & Entertainment District Overlay Expansion Project ("Project"). The Project includes updating portions of the General Plan and Town Center Specific Plan and amending the land use matrix and other provisions of the Santee Municipal Code. The Project also includes preparation of a Program Environmental Impact Report (EIR) to cover uses and projects within the District, to allow for more streamlined development within the District.

On December 8, 2021, the City selected the M.W. Steele Group, Inc. ("M.W. Steele") to provide professional services relating to the Project, including providing the following services as part of their scope of work:

- Create a Vision Plan for the Arts & Entertainment District with goals, design features, and implementation elements, such as design standards and allowed land uses; and
- Develop goals and policies based on data collection, analysis, public surveys, and workshops to formulate a visioning package; and
- Amend portions of the General Plan and Town Center Specific Plan to promote a concentration of arts, cultural, and entertainment-oriented uses, provide standards for public outdoor spaces and expand the geographic boundary of the district; and
- Develop special thematic signage and kiosk program for an iconic sign design; and
- Attend and participate in public workshops and City Council meetings; and
- Produce a Program Environmental Impact Report (EIR) supported by technical studies in compliance with the California Environmental Quality Act (CEQA).

M.W. Steele is a planning and architecture firm serving as the principal consultant and Project manager, leading a team of subconsultants that include: McCullough Landscape Architecture, tasked to provide landscape concept plans for the Project; Graphic Solutions, tasked with developing an iconic family of signs for the Project; Intersecting Metrics, tasked with providing a traffic analysis and mobility plan for the Project; and Helix

Environmental Planning, tasked with preparing the Program EIR and supporting technical documents for the Project.

After entering into an agreement with the City in January 2022, M.W. Steele initiated essential first tasks for the Project, including creating an updated vision plan for the Arts & Entertainment District ("visioning") and defining a new District boundary. Both tasks involved extensive public outreach and engagement, including an online survey, pop-up outreach booths at three City events, and two community workshops (see Exhibit C for survey results and a summary of the feedback provided at the pop-up booth events). The online survey garnered responses from 169 participants, while the community workshops had a combined attendance of about 60 participants. The findings from this public engagement and visioning component of the project were presented at a workshop before the City Council on August 24, 2022, where the Council was also presented with boundary options for the expanded Arts & Entertainment District. At this workshop, the City Council selected a final expanded District boundary consisting of about 320 acres entirely within the existing boundaries of the Town Center Specific Plan area (Exhibit D) and directed Staff to explore options for enhancing uses in proximate commercial areas outside of this selected boundary. Selection of a boundary for the District was an important component of the Project as it established a study area for the project to inform the preparation of the corresponding Program EIR. As such, minimal environmental work related to the preparation of the Program EIR was completed for the Project by M.W. Steele in the runup to this August 2022 workshop.

After the City Council workshop on August 24, 2022, M.W. Steele continued to work on finalizing the Vision Plan for the Arts & Entertainment District, which includes Project goals, conceptual land use maps and illustrations, and a comprehensive land use matrix that consolidates all the various uses allowed in the Town Center through all Specific Plan amendments and overlays (**Exhibit E**). As part of community outreach and engagement efforts, the following goals and suggestions for the Arts & Entertainment District are identified with the Vision Plan:

- Create a walkable "Downtown" that connects all uses including housing, arts, entertainment, retail, commercial and civic uses embodying an authentic character that fits Santee.
- Consider elements such as a community gathering place in the form of a "Town Square", farmer's markets and local vendors.
- Incorporate art, murals, live theater, dance, and music venues both indoors and outdoors, resulting in a regional destination.
- Consider parking structure(s).
- Incorporate night life for evening and after dinner entertainment.
- Incorporate unique and effective lighting and signs that "brand" the Arts & Entertainment District.
- Promote creativity and inventiveness on the part of the vendors and local businesses in the district.

- Pedestrian areas should be tree lined to provide shade with water features with a naturalized design that recalls the river.
- Santee's weather should be considered a positive for year-round activities. Public spaces should support this concept.
- Open space, parks, youth programs and health-oriented activities should be integrated into the District.

Although a Vision Plan for the Project has been completed, much of the environmental work for the Project has not. Due to two San Diego Association of Governments (SANDAG) grants awarded to the City with similar environmental efforts as those laid out for the Project, City Staff directed M.W. Steele to cease environmental work and other tasks for the Project to allow time for the City to coordinate with SANDAG and M.W. Steele on a revised scope of work that would consolidate planning and environmental efforts related to the Project and the two grants as detailed in Section C of this report that follows.

#### C. <u>PROPOSED PROJECT REVISION</u>:

During the months the visioning and boundary definition tasks for the Arts & Entertainment District Expansion were underway, Staff applied for and received two San Diego Association of Governments (SANDAG) grants related to the Town Center Specific Plan area: a Housing Acceleration Program (HAP) grant for \$264,000 and Smart Growth Incentive Program (SGIP) grant for \$400,000. The HAP grant funds the preparation of an Environmental Impact Report (EIR) for the Town Center Specific Plan Update, specifically to cover future multifamily and mixed-use housing development within the Town Center. Completion of an EIR would allow for streamlining of development within the Town Center by allowing future development consistent with the Town Center Specific Plan to tier-off of the EIR. The SGIP grant funds an update to the Santee Town Center Specific Plan, including updating goals, policies, and objectives as well as to tables, charts and graphics. The SGIP grant also augments existing efforts to expand the Arts & Entertainment District boundaries and promote new development within the District, including mixed-use housing, specialty commercial uses, and entertainment uses. With the SGIP grant, Staff was able to leverage the existing City allocation for the Project and receive matching funds.

The receipt of these two SANDAG grants for the Town Center area represents an opportunity to consolidate the goals and objectives related to the Arts & Entertainment District Expansion Project with those of the grants. The City Council adoption of the Housing Element Rezones on October 12, 2022 that applied mixed-use and high-density residential land uses to several major landholdings within the Town Center also represents a major opportunity to revise the Project scope. The opportunity exists for a comprehensive Town Center Specific Plan Update that integrates the Arts & Entertainment goals and concepts with the mixed-use and high-density residential areas in the Town Center established by the Housing Element Rezones. Based on these factors, Staff has coordinated with M.W. Steele and SANDAG to formulate a consolidated approach that would result in a comprehensive update to the entire Town Center Specific Plan and expanded Arts & Entertainment District, while adhering to the approved grant

activities as required by SANDAG. This consolidated effort would also allow for enhanced uses in proximate areas outside of the boundaries of the Arts & Entertainment District, as previously directed by Council.

Both grants and the City-funded efforts have extensive overlap in tasks related to the preparation of a Program EIR. M.W. Steele has revised their proposed Scope of Services (see attached draft Resolution Exhibit A) to reallocate City funds from environmental review tasks to tasks related to the preparation of Town Center Specific Plan and Arts & Entertainment District land use plans, site plans, landscape plans, graphics and the development of design and development standards ("plan making"). Meanwhile, the two SANDAG grants would support activities primarily focused on the preparation of the Program EIR and technical documents, but also support plan making activities, such as the preparation of a sign program for the Town Center and Arts & Entertainment District.

As part of this revised scope, Staff would manage public outreach and engagement, including the presentation of plan alternatives at five community workshops (one in each Council district and one at large) and three subsequent City Council workshops. The community workshops would be held at a venue within each respective City Council District, with the at-large workshop held at City Hall. Staff would coordinate with each Councilmember on a date and venue for their corresponding district workshop. M.W. Steele will work and draft master site plan concepts, land use plans, landscape plans and architectural illustrations to present to the public for selection of preferred options by participants at these workshops. The findings from these community workshops will then be presented to the City Council at a workshop where the Council will have the opportunity to select a preferred plan alternative with land use and architectural design options. Upon Council direction, Staff will then work with M.W. Steele on plan making and preparing a draft Town Center Specific Plan Update that will be presented to the City Council and to the public at a subsequent workshop. After input from the Council and the public, the draft Town Center Specific Plan Update will be finalized and presented to the Council for approval at a third workshop anticipated before September 2023. The updated Town Center Specific Plan would include the following elements:

- An updated land use map with land use designations that relate to existing and envisioned/desired development.
- An updated land use table expanding on allowable uses for each land use designation especially for those designations that encourage Arts & Entertainment uses.
- Updated development standards for all land use designations with revisions to stories, height, setbacks, lot coverage and open space requirements that foster the type of mixed-use and entertainment-type uses envisioned for the Town Center.
- Updated design standards for residential, commercial, and mixed-use buildings that include revised objective design standards for by-right multifamily residential and mixed-use residential development. For the Arts & Entertainment District, tailored design standards and concepts.

- Updated improvement standards for streets, sidewalks, parkways, trails, paseos, and water features and corresponding street furniture and light standards within the Town Center that ties in an Arts & Entertainment motif.
- A new landscape palette in the Specific Plan that encourages shaded walkways and paseos and that creates a consistent high-quality landscape design aesthetic.
- Landscape lighting standards, including for tree canopy luminaires, particularly in the Arts & Entertainment District.
- New sign standards that encourage strategically placed iconic/gateway signage, as well as monument sign and wall sign requirements for all new development and new tenants in the Town Center.
- A comprehensive sign program for the Arts & Entertainment District with exciting sign concepts.
- An area master site plan that ties in all of the new standards with a layout of buildings, streets, paseos, trails, water features, parks, promenades, and amphitheaters with maximum potential building stories/heights and square footages that developers can utilize to guide their project proposals allowing for a streamlined approach to development within the Town Center.


The adopted draft Town Center Specific Plan Update with the foregoing elements would, in turn guide the preparation of the corresponding Program EIR, with certification of a Final EIR and adoption of a new Town Center Specific Plan anticipated by September 2024. The adopted Town Center Specific Plan Update and Program EIR would then allow for streamlined development of projects consistent with the new Town Center Specific Plan, with the goal of helping a vibrant Arts & Entertainment District to materialize. As the proposed update only involves the refinement of already allowed commercial uses within the Town Center and would not propose any new housing not already established by the Housing Element Rezones, it would not increase the residential density permitted by law, make changes to the General Plan Residential Land Use categories that would intensify use, make changes to the land use designation of any parcel in a manner that intensifies use, nor make changes to slope criteria, minimum parcel sizes, or lot averaging provisions of the General Plan that would permit increased density or intensity of use. Therefore, the proposal would not be subject to Measure N.







Which of the following indoor uses would you like to experience as part of Santee's Arts & Entertainment District?


## POP-UP OUTREACH FEEDBACK AT-A-GLANCE






EXHIBIT D

**WHEREAS**, the City of Santee ("City"), under the Professional Services Agreement authorized by the City Council on December 8, 2021 and executed on January 24, 2022 ("Agreement"), retained M.W. Steele Group, Inc. ("Consultant"), to provide professional services relating to the Arts and Entertainment District Overlay Expansion Project ("Project"), and the associated Environmental Impact Report; and

WHEREAS, in January of 2022 the City applied for a grant in the amount of \$264,000 under the Regional Early Action Program Housing Acceleration Program (HAP) Grant Program to assist the City in completing a project-level environmental impact report for several multifamily and mixed-use housing sites within Town Center in order to streamline and accelerate housing production on these sites; and

**WHEREAS,** in March of 2022 SANDAG awarded the City a HAP Grant in the amount of \$264,000 with no requirement for matching funds; and

WHEREAS, in February of 2022 the City applied for a grant in the amount of \$400,000 under the Smart Growth Incentive Program (SGIP) Grant Program to assist the City in providing an update to the Town Center Specific Plan; and

**WHEREAS,** in August of 2022 SANDAG awarded the City a SGIP Grant in the amount of \$400,000 with a requirement that the City provide \$400,000 in matching funds. These matching funds are currently appropriated for the Project, and are being used to fund the City's current Agreement with the Consultant for professional services related to the Project; and

WHEREAS, both the HAP grant and SGIP grant cover the Town Center Specific Plan area and similar tasks as those approved with the existing Agreement with the Consultant: and

**WHEREAS,** a revised Scope of Services is included in the draft First Amendment attached hereto as Exhibit A, and consolidates the approved tasks associated with the Project, the HAP grant, and the SGIP grant; and

**WHEREAS**, the revised Scope of Services would result in an updated Town Center Specific Plan, expanded Arts & Entertainment District, and corresponding Program Environmental Impact Report that would achieve the same goals and objectives of the Project and the respective grants; and

#### **RESOLUTION NO.**

**WHEREAS,** an additional appropriation of funds by the City is not required for the revised Scope of Services; and

**WHEREAS,** this First Amendment is authorized pursuant to Sections 3, 4 and 14 of the Agreement; and

**WHEREAS**, the approval of this First Amendment will not result in a direct or indirect impact on the environment, is an administrative activity of government, and is therefore not a "project" under CEQA pursuant to State CEQA Guidelines § 15378.

**NOW, THEREFORE BE IT RESOLVED** by the City Council of the City of Santee, California that the City Manager is authorized to execute the First Amendment to the Agreement, consolidating tasks and activities associated with the Project, HAP grant, and SGIP grant, as attached hereto in substantially final form as Exhibit A, and is authorized, in consultation with the City Attorney's Office, to make minor revisions to the attached First Amendment that match the intent of the parties and ensure parity of City's standard contract terms prior to execution.

# FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT BY AND BETWEEN CITY OF SANTEE AND M.W. STEELE GROUP, INC.

This First Amendment ("First Amendment"), dated this day of
2023, for reference purposes only, is entered into by and between the City of Santee, a
California charter city ("City") and M.W. Steele Group, Inc., a corporation ("Consultant")
City and Consultant are sometimes referred to in this Amendment individually as a "Party
and collectively as the "Parties." This First Amendment is entered into in light of the
following recited facts (each a "Recital").

#### **RECITALS**

- A. City, under the Professional Services Agreement dated January 24, 2022, authorized by the City Council on December 8, 2021 ("Agreement"), retained Consultant to provide professional services relating to the Arts & Entertainment District Overlay Expansion Project ("Project") as well as the associated Program Environmental Impact Report.
- B. City and the Consultant now desire to amend the Agreement and execute this First Amendment to modify the Scope of Services to consolidate approved tasks for the Project, the Housing Acceleration Program (HAP) grant, and the Smart Growth Incentive Program (SGIP) grant and extend the end of the term of the Agreement, from January 24, 2024 to June 30, 2025 for additional project management services related to the completion of the Project.
- C. This First Amendment is authorized pursuant to Sections 3, 4 and 14 of the Agreement.
- NOW, THEREFORE, in consideration of the Recitals and the terms and conditions set forth in this First Amendment, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties set forth their mutual covenants and understandings as follows:

#### **TERMS**

- 1. <u>SCOPE OF SERVICES</u>: The Scope of Services, Agreement Exhibit "A", is hereby revised to include the Scope of Services (First Amendment), attached to this First Amendment as Exhibit "A" and incorporated into this First Amendment by this reference.
- 2. <u>COMPENSATION</u>: Section 2 of the Agreement is hereby amended to increase the not-to-exceed amount paid for services rendered by Consultant pursuant to the Agreement by \$624,000.00 from the previous amount of \$400,000.00 to the amended amount of \$1,024,000.00. The \$624,000.00 in additional funding will be paid by the HAP and SGIP grants, as set forth in the attached Exhibit "A" Scope of Services (First Amendment) page 12 "Budgets for Each Grant Awarded to City of Santee by SANDAG" and page 13 "Assignment of Proposed Scope and Budget."

3. <u>TERM</u>: Section 3 of the Agreement, "Term of Agreement and Time of Performance" is hereby revised to read, in its entirety, as follows:

Consultant shall perform its services hereunder in a prompt and timely manner, and in accordance with the Scope of Services shown in Exhibit "A" attached hereto and made a part hereof; provided, however, that the contents of this Agreement, as amended, shall supersede any provisions in Exhibit "A" that are inconsistent therewith. Work shall commence upon authorization from the City. Unless a different date is set forth in the Activity Schedule, the term of the Agreement shall be from the date of execution of the Agreement through June 30, 2025 unless terminated sooner pursuant to the provisions of this Agreement or when the services are complete. Such term may be extended upon written agreement of both City and Consultant.

4. <u>CONTINUING EFFECT OF AGREEMENT</u>. Except as amended by this First Amendment, all other provisions of the Agreement and First Amendment remain in full force and effect. From and after the date of this First Amendment, whenever the term "Agreement" appears in the Agreement, it shall mean the Agreement as amended by this First Amendment and First Amendment.

# Proposal to Amend the Arts & Entertainment District Overlay Update Contract

This proposed amendment to the contract between the City of Santee and MW Steele Group (prime consultant), executed on January 24, 2022, is to increase the scope of work and fees to allow for the team of consultants currently working on the Arts and Entertainment District efforts. This will be accomplished by expanding their scope of work and budget to provide planning and environmental services related to completing a technical update to the 1986 Town Center Specific Plan (SGIP grant) and conducting project-level environmental analysis four large strategic sites consisting of approximately 37.5 undeveloped acres within the Town Center Specific Plan (HAP grant).

The current \$400,000 contract for the update of the Arts and Entertainment District would be amended with this action by the addition of \$624,000 (which allocates \$40,000 of the SGIP grant for City staff administration time) to expand the scope of work outlined above. The entirety of this amendment is funded by the SGIP and HAP SANDAG grants.

# **Proposed Amendment**

# Ongoing Effort

The City of Santee, supported by the consultant team, which consists of MW Steele Group, RRM Design Group, Helix Environmental, McCullough Landscape Architecture, Intersecting Metrics, and Graphic Solutions, is currently conducting a planning effort related to updating and expanding Santee's Arts and Entertainment District, which is a subarea of the Town Center Specific Plan.

## Grant-Funded Efforts

In addition to the ongoing Arts and Entertainment District planning effort, the City of Santee has been awarded two grants by San Diego Association of Governments (SANDAG), and is proposing to utilize the funding as follows:

Utilize the **Smart Growth Incentive Grant Program (SGIP)** funds (\$400,000 added to the city match) to conduct a technical update to the Town Center Specific Plan, which was adopted in October 1986, the update will ensure consistency between the City's General Plan Land Use Element, Mobility Element goals and Active Santee Plan.

Utilize the **Housing Acceleration Program (HAP)** grant funds (\$264,000) to complete project-level environmental analysis for four large strategic sites consisting of approximately 37.5 undeveloped acres within the Town Center Specific Plan, which would allow for by-right or ministerial approval of new housing development.

# Proposed Approach to Completing and Coordinating Three Programs

City Staff and our team of consultants proposes to conduct a comprehensive planning and environmental approach that encompasses the three planning efforts:

- A. The on-going tasks of the Arts and Entertainment District update and expansion.
- B. The technical update to the 1986 Town Center Specific Plan (SGIP grant).
- C. The project-level environmental analysis of four large strategic sites consisting of approximately 37.5 undeveloped acres within the Town Center Specific Plan (HAP grant).

A single comprehensive planning effort will be possible since the three planning efforts are contained within the same geographic area, the boundaries of the Town Center Specific Plan. The proposed approach will result in an efficient use of resources since a single Environmental Impact Report is proposed to be prepared, instead of three separate environmental documents.

# Contract Amendment

To accomplish the efforts outlined above, City Staff proposes an amendment to the contract between the City of Santee and MW Steele Group (prime consultant), executed on January 24, 2022, to allow for the team of consultants currently working on the Arts and Entertainment District efforts, to expand their scope of work and budget to provide planning and environmental services related to completing a technical update to the 1986 Town Center Specific Plan (SGIP grant), and conducting project-level environmental analysis four large strategic sites consisting of approximately 37.5 undeveloped acres within the Town Center Specific Plan (HAP grant).

# A, Arts and Entertainment District

The Arts and Entertainment District Update is an ongoing project being executed by the consultant team.

The plan is well underway now and staff along with the consultant team have completed public outreach and stakeholder workshops. An overall concept for circulation, land use and open space has been developed at this writing and further work will be undertaken in coordination with the SCIP and HAP grant tasks.

The overall concept that has been developed in concert with the above mentioned outreach is one that integrate all the uses with the district creating a mixed use walkable environment that includes both night and day activities. The concept will add residents to the district and unite the new and future uses on both sides of the river. The Arts and Entertainment District will represent the best of Santee businesses and arts. The district will continue to be family oriented, attractive in all seasons and all times of day. Safe, inviting, active and stimulating, the Arts and Entertainment District will become "Downtown Santee".

The proper implementation of the Arts and Entertainment District will be assured through it's inclusion in the Town Center Specific Plan through and amendment to that plan.

- Circulation plan including river access and crossings, public plazas, pedestrian, and vehicular elements.
- Open space plan identifying locations and uses of various open space elements of the plan area.
- · Iconic sign plan that establishes location, design, and character of various signs.
- Land use plan alternatives identifying Arts and Entertainment land uses as well as various supporting uses such as mixed-use residential areas.
- Design guidelines for the Arts and Entertainment uses and areas that identify heights, setbacks, and character.
- · Text describing the goals and objectives of the Arts and Entertainment District.

# B. Smart Growth Incentive Grant Program (SGIP)

The proposed technical update to the Town Center Specific Plan will result in a graphically rich, easy-to-use Specific Plan document poised to carry out the community's vision. The technical update will include the recommended formatting for the document, draft text for the sections proposed to be amended, including related development standards and all associated high-level maps and exhibits for the document. The preparation of the Specific Plan Technical Update is expected to be an iterative process involving drafting and refinement in collaboration with City staff. Coordination of the Town Center Specific Plan Technical Update with the Arts and Entertainment District, and the Housing Acceleration Program efforts is essential to ensure consistency and a seamless implementation.

#### Amend the General Plan and Town Center Specific Plan

#### Refining Goals and Generating Plan Alternatives

Our team will work with staff refine the goals to goals developed through community via workshops and stakeholder meetings. Based on these goals our design team will create a minimum of three (3) plan alternatives. These alternatives will be reviewed by stakeholders in three (3) charrettes and as conducted by City Staff and two (2) City Council workshops. A selected alternative will be taken forward and developed as the preferred option in the EIR and included as the land use plan in the Town Center Specific Plan.

#### Administrative Draft Specific Plan Technical Update and EIR

Our team will incorporate the text from the 1986 Town Center Specific Plan into the updated template. Our team will incorporate revisions to the content that address clarity, relevance, and applicability. The technical update will include replacing black and white photographs with high resolution full-color photographs to support the text and content of the Specific Plan. The update will also result in enhanced text and graphics to enable users to understand the requirements and process for development within the Town Center Specific Plan area. Or team will also update the Town Center Specific Plan include a flowchart of the specific plan administration process. Our team will incorporate the following as part of the Specific Plan:

- Illustrative land use plan alternatives and zoning map that combines the Arts and Entertainment District, housing district, existing retail, sports complex, public buildings and uses as well as other elements of the plan area.
- Objective Design Standards will be tested for effectiveness in creating the desired overall urban design intent and modified or additional standards added as required.
- Traffic Engineering and circulation plan identifying public squares and plazas, pedestrian linkages, and public and private vehicular routes.
- Landscape plan including public spaces and circulation elements such as intersection and pedestrian ways.
- Iconic sign design plan and standards for wayfinding and identity establishing signs.
- Lighting objectives and standards.
- · Allowed land use matrix.
- Program Environmental Impact Report.

#### Screencheck Draft Specific Plan Technical Update

Following the completion of the Administrative Draft Specific Plan Technical Update and receipt of the single set of redlined comments from the City on the Administrative Draft, our team will produce a Screencheck Draft Specific Plan. At this point, all of the City's comments will have been integrated, and this draft will provide an additional internal review opportunity prior to the development of the Public Review Draft.

# C. Housing Acceleration Program Grant (HAP)

Our team will support City staff on the implementation of their Housing Element, by completing project-level environmental analysis for four large strategic sites consisting of approximately 37.5 undeveloped acres within the Town Center Specific Plan, which would allow for by-right or ministerial approval of new housing development where more than 20% of the housing units are affordable to low-income households. #### **ENVIRONMENTAL IMPACT REPORT AND TECHNICAL STUDIES**

HELIX Environmental Planning, Inc. (HELIX) is proposing to augment their original scope of work, to include the entirety of the Santee Town Center Specific Plan area boundary and addressing the four housing element sites (16A, 16B, 20A, and 20B) located within the Town Center boundary. While the Town Center Specific Plan amendments will be addressed at a program level of analysis, it is anticipated that the four housing element sites will be analyzed at a project level of detail given conceptual building footprints and design standards provided by the City and Client team.

### **Technical Studies**

HELIX will adjust the in-progress technical studies listed below to include and analyze the broader Town Center Specific Plan amendments and conceptual development plans for the four housing element sites. As with our currently contracted scope of services and unless otherwise noted, for each technical study listed below, our team will prepare one Screencheck Draft and one Public Review Draft. The two drafts of each study will be provided in Word and PDF formats. For other environmental topics not requiring formal technical studies, our team will gather data from existing sources, including information prepared for the visioning and planning efforts and from online databases and prior reports, incorporating the research directly into the EIR.

#### Air Quality

HELIX will analyze future development and proposed infrastructure within the Santee Town Center Specific Plan Amendment area at a program level of detail. The air quality analysis will also provide project level analysis of four housing element sites (16A, 16B, 20A, and 20B). Analysis will include modeling of the sites using site plans and building designs provided by Client. Modeling will be performed using CalEEMod, and will be analyzed against relevant thresholds. The analysis will be incorporated into one air quality technical report addressing the Santee Town Center Specific Plan Area, the Santee Art & Entertainment District Overlay, and the four housing element sites.

#### **Biological Resources**

HELIX will perform a California Natural Diversity Database search, conduct a general biological reconnaissance survey, and prepare a biological resources technical report to be submitted to the City. The biological resources technical report will identify potential direct and indirect biological impacts that could occur from future development and new infrastructure proposed in the Santee Town Center Specific Plan area and specifically address the four housing element sites (16A, 16B, 20A, and 20B) located within the Town Center boundary. This report will describe the survey methods employed, present the results of the fieldwork, assess the potential for sensitive resources to occur in the project area, identify regulatory issues related to the resources located within the Project area, and estimate potential extent of resources. This Project area will be analyzed for impacts based on California Environmental Quality Act (CEQA) requirements and thresholds. The report will recommend potential programmatic mitigation measures to be applied to future projects within the Santee Town Center Specific Plan study area and project level mitigation measures for the four housing element sites 16A, 16B, 20A, and 20B study areas. No focused surveys will be conducted, and a formal delineation will not be conducted.

#### Cultural Resources

HELIX will obtain an updated records search from the South Coastal Information Center (SCIC) of the expanded Santee Town Center Specific Plan Area and a A-mile radius around it. HELIX will review records search data and previous cultural resources reports for the Specific Plan Area, including the EIR and cultural resources technical report (if any) for the Housing Element. Due to the adjusted study area and project components, HELIX will send updated letters to the tribal contacts previously notified of the Project in order to solicit information they may have regarding the Native American sensitivity of the Specific Plan Area and Housing Element sites. No additional fieldwork is proposed as part of the scope. The sites in the Housing Element within the Specific Plan Area have already been surveyed for cultural resources; those results will be included in the technical report for this Project. HELIX will prepare a draft technical report summarizing the record search methods and results, the geologic and soil conditions of the Project area, the results of a review historic maps and aerial photographs of the Project area, and Tribal outreach. The report will provide recommendations for the treatment of cultural resources located within the Project area that cannot be avoided by future project redesign.

#### Greenhouse Gas Emissions

HELIX will analyze future development and proposed infrastructure within the Santee Town Center Specific Amendment area at a program level of detail. The greenhouse gas emissions analysis will also provide project level analysis of four housing element sites (16A, 16B, 20A, and 20B). Analysis will include modeling of the sites using site plans and building designs provided by Client. Modeling will be performed using the appropriate modeling software, and will be analyzed against relevant thresholds. The analysis will be incorporated into one greenhouse gas emissions technical report addressing the Santee Town Center Specific Plan Area, the Santee Art & Entertainment District Overlay, and the four housing element sites

#### Noise

HELIX staff will perform an additional site visit and take existing noise measurements at up to four additional locations within the Santee Two Center Specific Plan area. HELIX will analyze future development and proposed infrastructure within the Santee Town Center Specific Amendment area at a program level of detail. The analysis will also provide project level analysis of four housing element sites (16A, 16B, 20A, and 20B). Analysis will include modeling of the sites using site plans and building designs provided by Client. Modeling will be performed using the appropriate modeling software, and will be analyzed against relevant City thresholds. The analysis will be incorporated into one noise technical report addressing

the Santee Town Center Specific Plan Area, the Santee Art & Entertainment District Overlay, and the four housing element sites.

#### **Draft Program EIR**

#### Environmental Scoping

HELIX will update Project scoping materials (i.e., the Notice of Preparation [NOP]), including the Project location, boundaries, and description to incorporate the Santee Town Center Specific Plan area and the four housing element sites. Consistent with the original contracted scope of work, no Initial Study will be prepared.

#### Screencheck Draft EIR

Using information developed in the Technical Studies above, HELIX will incorporate and analyze the Santee Town Center Specific Plan area amendments and the four housing element sites in the Screencheck Draft EIR.

#### Public Review Draft EIR

HELIX will incorporate and analyze the Santee Town Center Specific Plan area amendments and the four housing element sites into the Public Review Draft EIR.

#### **Final Program EIR**

#### Responses to Comments and Final EIR

HELIX will address responses to comments associated with the Santee Town Center Specific Plan Amendment and the four housing element sites in the Final EIR.

#### Findings; Mitigation, Monitoring and Reporting Program; and Statement of **Overriding Considerations**

HELIX will incorporate the Santee Town Center Specific Plan Amendments and the four housing element sites in the Findings, MMRP, and SOCs for the Project.

#### **Environmental Team Project Management**

As the HAP grant does not address Project Management as a separate line item, additional Project Management activities related to the augmented scope of work and extended schedule, including coordination, progress reporting, and quality control reviews, have been incorporated within the tasks above.

#### Environmental Team Meetings and Hearings

HELIX will participate in coordination meetings with Client and staff to prepare for the public hearings. HELIX will also review drafts of the hearing presentations and the City staff report. HELIX staff will also participate in up to two hearings and prepare the Notice of Determination. This scope of work does not include preparing presentations or staff reports to support the hearings. This scope of work also assumes the NOD will be filed by the City and HELIX will not incur or pay any filing fees.

#### MULTI-MODAL PLANNING ANALYSIS

The Town Center Specific Plan identifies a network of interconnected bike and pathways linking activity centers, as well as linking the Town Center with the bike and pedestrian trail system in the rest of the City. In addition, the City of Santee's Mobility Element states that the City should create a vibrant Town Center by developing a connected system of multi-modal corridors that encourage walking, biking, and riding transit. Intersecting Metrics (IM) will re-evaluate and update the planned mobility network within the Santee Town Center (Town Center) area, based on the proposed land use changes and current practices

#### **Existing Conditions**

IM will collect and document the following multi-modal data within the Town Center area:

- Existing Pedestrian pathways and sidewalks, both within and accessing the Town Center area.
- Existing Bicycle facilities both within and accessing the Town Center area.
- Existing Transit stop locations and routing information, including MTS Trolley and buses, serving the Town Center area.
- Planned bicycle and pedestrian infrastructure changes/improvements within and around the Town Center area.
- Planned changes to the transit network accessing the Town Center area based on the 2021 Regional Plan.

#### **Multi-Modal Planning and Evaluation**

IM will work with the Project Team and City staff to develop a non-vehicular transportation network within the Town Centre area. The proposed network will provide connections between commercial, residential, mixed-use development, the trolley station, and the trails along the San Diego River. IM will evaluate the different facility types that are needed within the Town Center area, as well as the potential conflicts between modes at the connection points. IM will identify potential treatments along the multi-modal facilities to limit and organize the conflict points, and create a safe environment for all modes of travel. IM will also identify locations in which features such as such as bikeshare, bike parking, carshare, neighborhood electric vehicles, real-time traveler information, demand-based shuttle services, wayfinding signage should be provided, particularly at the Trolley station. Finally, IM will evaluate how the transportation network internal to the Town Center area will connect and interface with the City's existing transportation network.

#### **Mobility Design Standards**

IM will work with the Project Team and City staff to develop design standards for pathways, pedestrian linkages, and wayfinding signage. Design standards will be based off existing City of Santee Design Standards, as well as the standards outlined the Highway Design Manual (HDM), the National Association of City Transportation Officials (NACTO) Urban Street Design Guide, and the California edition of the Manual on Uniform Transportation Control Devices (MUTCD). The design standards will be incorporated into transportation section of the Town Center Specific Plan.

#### **Roadway Network Analysis**

To understand the effect the increase in land use density proposed within the Town Center area will have on the surrounding transportation network, a vehicular level or service (LOS) analysis will be conducted. The purpose of the analysis will be to determine if additional roadway network or access improvement will be needed to accommodate the additional density. It should be noted that this analysis will only be conducted for informational purposes and will not be included within the Proposed Project's CEQA documentation.

#### **Data Collection**

IM will collect the following transportation related data for the Proposed Project:

#### Roadway and Intersection Geometry

IM will verify the existing intersection and roadway geometrics through field observations.

#### Traffic Counts

The existing traffic counts from the Fanita Ranch Transportation Impact Study, which were

conducted in 2018, will be used for the external public roadway accessing the Town Center area. New traffic counts will be conducted at up to eight driveway locations accessing the Town Center area to provide a focused access analysis.

#### Signal Timing

IM will coordinate with City staff to get the existing signal timing plans for all signalized study area intersections.

#### **Cumulative Projects**

IM will coordinate with City staff to identify all cumulative projects that may contribute traffic to the project study area. IM will also review recently approved traffic studies and Local Mobility Assessments (LMAs) to identify the cumulative project's trip generation, distribution, and assignment.

#### Horizon Year Volumes

The Year 2035 With Project volumes assumed within the Fanita Ranch Transportation Impact Study will be used as the baseline for Horizon Year conditions. Any identified cumulative projects not assumed within the Fanita Ranch Transportation Impact Study will also have their anticipated traffic assignment added to the baseline Year 2035 traffic conditions. Note: no unique SANDAG sub-area model runs are anticipated for this effort. Should a SANDAG sub-area model run be needed for this effort a scope and budget augmentation will be required.

#### **Existing Conditions Analysis**

IM will conduct an LOS assessment of the existing transportation network adjacent to and accessing the Town Center area. It is assumed that the study area will consist of 12 external intersections, eight driveway locations, and 14 roadway segments.

#### **Horizon Year Analysis**

IM will conduct a focused LOS analysis for up to three project alternatives. The focused LOS analysis will evaluate the changes in project traffic entering and exiting the Town Center area based on different land use and access alternatives. It is assumed that not all of the three project alternatives will require a full analysis of the study area and will instead only focus on the Town Center driveways and the adjacent external intersections.

#### Parking

All three projects have a goal to reduce the existing parking requirements within Town Center area and at the transit station. IM will work with the Project team and City staff to develop a parking management plan for the Town Center area that encourages shared parking opportunities, provides flexibility in the application of parking standards to support transit-oriented development, evaluates time limited parking areas, identifies curb space management opportunities, proposes parking consolidation, evaluates the potential for unbundled parking, identifies parking enforcement techniques, as well as other parking management techniques. IM will review market rate parking programs that have been implemented by peer jurisdictions (San Diego, Portland, Seattle, and Austin). These parking management measures will be included as policies within the Town Center Specific Plan. Additionally, IM will develop a parking management toolbox that can be included in the Town Center Specific Plan that identifies the different parking management requirements for developments who choose to provide reduced on-site parking.

#### Multimodal Mobility Specific Plan Documentation

IM will work with the Project Team and City staff to develop the Transportation Section of the Santee Town Center Specific Plan. This includes a description of the existing transportation network, the transportation and parking related improvements / changes envisioned with the build out of the plan, the transportation related design standards and the transportation and parking related goals and policies.

#### **Multimodal Mobility CEQA Analysis**

The Proposed Project EIR will consist of both programmatic and project level components. The Santee Arts and Entertainment District and Santee Town Center Specific Plan projects will be evaluated at a programmatic level, while the Town Center Multifamily Housing Sites project will be evaluated at the project level.

The impact analysis for the different projects, both at the programmatic and project level, should screened out from conducting a detailed analysis. The Santee Towne Center Trolley Station is located within the identified project boundary for all three projects. Based on The City of Santee VMT Analysis Guidelines and Section 15064,3(b)(1) of CEQA guidelines, land development projects located within a 1/2 mile of a major transit stop (Transit Priority Area) are assumed to have a less than significant VMT related impact. Therefore, a detailed VMT impact analysis should not be required for the any of the projects. It is assumed that there will be no net increase in retail uses within the project boundary, thus a market assessment will not be required. Additionally, it is assumed that the proposed land use changes will not need to be included within the SANDAG model to determine the associated change in VMT. If a market study or a unique SANDAG model run would be required to complete the EIR, a scope and budget augment will be needed.

A qualitative analysis will also be conducted for any proposed transportation network changes. The qualitative analysis will determine if a proposed network change has the potential to induce vehicular travel within the City. The induced travel analysis will be conducted based on the list of transportation projects included within Appendix F of the City of Santee CMT Analysis guidelines. IM will draft the Transportation section of the Proposed Project EIR to document VMT findings. IM will also provide an impact analysis for the other three included in the CEQA checklist, under the transportation section. IM staff will provide up to 10 hours of support in responding to transportation related public comments on the project EIR. IM staff will attend up to two hearings for the Proposed Project.

The current contract is for \$400,000 for an update of the Arts and Entertainment District which will be amended with this action by the addition of \$624,000 (which assumes \$40,000 of the SGIP grant is allocated towards City staff administration time) to expand the scope of work to include an update of the Town Center Specific Plan and planning and objective design standards for the residential component of the plan, including the environmental impact report.


