# **NON-AGENDA PUBLIC COMMENT: (Continued)**

- (A) Aaron Hackett, Santee Firefighter Association, discussed the upcoming Demolition Derby at the San Diego County Fair on July 7th, highlighting that donations received will benefit the Burn Institute; he stated the Burn Institute provides support services, including Camp Beyond the Scars, a weeklong camp for children who are burn victims.
- (B) Brenda Hammond spoke about being an East County resident and her experiences in the community.
- (C) Mary Davis expressed how the changes in the upcoming Metropolitan Transit System (MTS) copper line affect citizens that ride public transit, and urged Council to consider the people the changes will impact.

# **CITY COUNCIL REPORTS:**

Councilmember Hall reported about the MTS copper line coming to the Santee Trolley station; he also emphasized there would be increased security measures and that wait times are expected to decrease once the copper line is installed.

Councilmember Koval spoke about a San Diego Association of Governments (SANDAG) meeting she attended, and the Borders Committee meeting regarding the copper line and the safety and security of the riders.

Councilmember McNelis discussed meeting with the General Manager of SportsPlex USA while viewing the new field and requested that the extension of the contract be included on an upcoming Council Agenda.

Mayor Minto shared information about the discussions at the SANDAG Tribal Summit and mentioned his attendance at the upcoming League of California Cities meeting next month.

# **CITY MANAGER REPORTS:**

The City Manager expressed gratitude to the City Council for their discussion and support of the Agenda items presented during the Council Meeting; she also reminded the community about the upcoming Santee Summer Concert on June 27th featuring Journeyman, and the Santee Salutes event on the 4th of July.

## **CITY ATTORNEY REPORTS:**

The City Attorney provided an update on the California Supreme Court case regarding the Taxpayer Protection and Government Accountability Act, also known as the California Business Round Table Initiative; the initiative was slated for the November 2024 statewide ballot but was deemed a revision to the Constitution rather than an amendment by the California Supreme Court.; as a result, the initiative was removed from the ballot' this decision has significant implications for the approved local ballot measure, which will now be subject to a simple majority standard.
