Alicia Curtis, Recreation Coordinator, spoke about an upcoming blood drive event; presented a promotional video for Fido Fest; spoke about the Discover Your Community & Tutu Fun Run event; and other upcoming events throughout the year.

Anne Morrison, Recreation Services Manager, presented a promotional video for the Heroes Golf Classic Tournament; spoke about various recreation programs; youth sports; and programs at the YMCA.

Sam Rensberry, Public Services Manager, provided an update on tree planting; the robot lawn mower at Weston Park; staff training; and plans for staff to take over landscaping services for all City parks.
