FINANCIAL ASSISTANCE FOR RECREATION PROGRAMS

Financial assistance for qualifying families and seniors *Fiscal Year 2025-2026*

The Community Services Department is proud to offer the Financial Assistance Program to increase access to recreation programs for Santee residents who meet the eligibility requirements. This program is available through funds raised by the Santee Park and Recreation Committee (SPARC) and Recreation Activity Donations.

Eligibility is based on age and income and is only available to Santee residents. Youth under the age of 18 and adults age 55 and over who meet the income requirements are eligible to participate in the program. Income eligibility is based on HUD income limits.

Instructions:

1. Complete the application and submit to the Community Services Department:

2. Submit residency verification (Driver's License, Checks, Utility Bill) with the application.
3. Eligible applicants will receive a letter from the Community Services Department granting participation in the program.
4. Each eligible recipient will receive up to a \$57 voucher per season to apply toward any recreation activity, trip and program offered through the City of Santee. Seasons: summer, fall, winter, spring.
5. Financial Assistance forms and proof of residency must be updated annually in June. A new form is not required each season or for each enrollment.
