

Chapter 4 Responses to Comments

4.1 Introduction

During the public review period (May 29, 2020, to July 13, 2020) for the Draft Revised EIR for the Fanita Ranch Project (proposed project), the City of Santee (City) received 216 comment letters. The comment letters and the City's responses to them are included in this chapter. The responses to comments are based on the California Environmental Quality Act (CEQA) Guidelines, Section 15088(c), Evaluation of and Response to Comments, which states the following:

The written response shall describe the disposition of significant environmental issues raised (e.g., revisions to the proposed project to mitigate anticipated impacts or objections). In particular, the major environmental issues raised when the lead agency's position is at variance with recommendations and objections raised in the comments must be addressed in detail giving reasons why specific comments and suggestions were not accepted. There must be good faith, reasoned analysis in response. Conclusory statements unsupported by factual information will not suffice. The level of detail contained in the response, however, may correspond to the level of detail provided in the comment (i.e., responses to general comments may be general). A general response may be appropriate when a comment does not contain or specifically refer to readily available information, or does not explain the relevance of evidence submitted with the comment.

Table 4-1 provides a list of the comment letters received from agencies, tribal entities, organizations, and individuals during the public review period (May 29, 2020, to July 13, 2020) of the Draft EIR. All comments and responses to comments have been assigned a letter (F [Federal Agency], S [State Agency], L [Local/Regional Agency], T [Tribal Entity], O [Organizations], and I [Individuals]). A copy of each comment letter with corresponding responses is provided in Section 4.3, Side-by-Side Responses to Comments.

As the CEQA lead agency and pursuant to California Public Resources Code, Section 21092.5, and CEQA Guidelines, Section 15088(b), the City provided each public agency that commented on the Draft Revised EIR a copy of the City's response to those comments at least 10 days before certifying the Final EIR.

As shown in Section 4.3, the comment letters have been divided into individual comments with each comment containing a single theme, issue, or concern. Each comment is bracketed and assigned a letter and number. Comment letters have been reduced to fit on the left side of a single page. The corresponding response and letter-number combination is provided on the right side of the page.

Any revisions to the Draft Revised EIR included in the responses to comments are indicated as underlined text (e.g., <u>underlined text</u>), and deletions are indicated as strikethrough text (e.g., <u>strikethrough text</u>). In Volume III, Chapter 2, Errata – Revisions or Clarifications to Volume I, Draft Revised EIR, and Chapter 3, Errata – Revisions or Clarifications to Volume II, Draft Revised EIR Technical Appendices, text changes resulting from the comments received are also indicated as underlined and/or as strikethrough text. Please note that the revisions do not affect the conclusions of the EIR.

Additional comments were received after the 45-day public review period, which ended on July 13, 2020, at 5:00 p.m. In accordance with CEQA Guidelines, Section 15088 (a), the comments received after the noticed comment period are not included in the Final EIR; however, they are part of the administrative record that will be considered by the City Council when deciding to approve or deny the proposed project.
