

## 2024 Residential Self Haul Exemption Application

California State Senate Bill 1383 (SB 1383) requires all businesses, multifamily and single-family residences to recycle their organic material, including food waste, beginning January 1, 2022, with no minimum threshold.

Santee City Municipal code 9.02 requires that compostable items such as food scraps, (fruits, vegetables, coffee, coffee grounds, meat scraps, bones, etc.) food-soiled paper (paper towels, paper plates, coffee filters, etc.) and yard trimmings (leaves, grass, etc.) are recycled and not placed in the trash.

Santee City Municipal code 9.02.120.B allows a generator to self-haul. In order to opt-out of Residential Solid Waste services, customers must indicate their plan for keeping compostable wastes out of the landfill. Compliance monitoring will occur and waiver may be revoked, with carts delivered and service account created by the City’s current Franchise Hauler. Renewal application will be due annually, by December 31. Beginning January 1, 2024, violations may be subject to administrative civil penalties (Santee Municipal Code 9.02.130.B.9).

To opt-out of receiving Solid Waste services at your residential address:

Step 1: Fill out this form and indicate how you will appropriately divert all materials from the landfill.

Step 2: Provide some form of proof of diversion of all recyclables, organic and inorganic (a picture of your compost pile or chicken coop, a signed letter from a farmer who is taking your organic wastes for composting, etc.). Monthly receipts from recycling center are required as well.

Step 3: Return the completed form to the City of Santee Community Services Department (10601 Magnolia Avenue, Santee, CA 92071, or scan and email it to [santeerecycles@cityofsanteeca.gov](mailto:santeerecycles@cityofsanteeca.gov)), along with appropriate documentation. You will be notified regarding the outcome of your request.
